- Leadership change in US House Oct 25<sup>th</sup>, Rep. Mike Johnson (R-LA) not active in education policy. New to leadership role. Funding issues that need to be addressed. FY 24 Appropriations. Current government funding expires on 11/17
- 2. FY 24 Appropriations
  - a. President's budget in March small increase in Perkins
  - b. Debt limit deal in May
  - c. House Labor, HHS, Education bill passed subcommittee in July, then stalled
  - d. Senate Laboar bill passed full appropriations committee, waiting on floor
  - e. New bill 30% cut to education and labor programs
  - f. Senate Bill \$40m increase for Perkins
    - i. Passed out of Senate AC
  - g. ACTE supports the Senate proposal
  - h. CR December, Jan or later
    - i. Laddered CR Proposed
    - ii. If not finished by Jan 1% across the board cut is triggered that could occur in April.
