Moved by Stuhrenberg and seconded by Hemer to approve the bills. Three ayes.

Nuisances were discussed. One on main street was the main focus. Council and Mayor discussed what progress has been made. Mayor stated he fears this is all that will get done. Council and Mayor decided to be sure they stay on top of progress to make sure things are continually getting done.

Nancy Janssen came to discuss her role in helping the new city clerk. She stated that she is with the Midwest Assistance Program and it's her job to help the city clerk and council as needed. She stated she is able to assist council in any training, help change things they would like to change, help find resources for the community, and several more services. She mentioned that this is at no cost to the city because it is funded by USDA Rural Development, Health & Human Services, and some state programs.

Citizens to be heard: Dale said that he attended the meeting to encourage everyone to vote to pass the Sac County jail vote. He stated he attended the town hall meeting they had and he didn't realize how bad the condition of the jail was. He asked the council to try to get the word out as much as possible.

Motion was made by Stuhrenberg and seconded by Duff to approve the following building permits: Paul Wayland- Handicapped Ramp. Mike Simon- Remove concrete steps and add deck. Three ayes.

Dollar General Alcohol Permit: Council asked Supt Michael if he was able to get ahold of anyone about the drainage issue at Dollar General. Will Wrye finally called back and stated he would pass the information on to their construction department. Council believes they need to lower the culvert to get the water to drain properly. Council decided to hold off on their Alcohol Permit approval until we hear from the city attorney. Motion was made by Hemer and seconded by Duff to table the renewal of Dollar General's Alcohol Permit until legal advice is given. Three ayes.

Proposals were opened on the building for E 1st St. Council was pleased all proposals stated to clean up the building. Council decided to accept the highest proposal being from Odebolt Soft Water Service. Motion was made by Hemer and seconded by Duff to accept the proposal from Odebolt Soft Water Service to get the building on E 1st St. Three Ayes.

Odebolt Sign Lease Agreement. Motion was made by Hemer and seconded by Duff to approve the land ground lease agreement for William Wallace Trust and Rachel Ann Wallace Trust. Three ayes.

Complaint File: Council reviewed complaint from Jill Hustedt about pot holes on Mandernach Drive.

Motion was made by Stuhrenberg and seconded by Duff to approve the library report. Three ayes.

The County Law Enforcement Report was available.

Supt Public Works Report: Michael reported that he ordered new meters to install. He said the lights were installed from the MidAmerica Grant and they work/look great. He stated he looked at Mandernach Drive and reported that the road isn't as bad as some of the others in town. Michael and council discussed possibly purchasing a power washer for getting the salt and sand off of the vehicles during winter. He stated it would also be good to use at the pool. Council agreed that it might be a good idea.

Committee Reports: Council and Mayor discussed Mandernach Drive. They agreed there are multiple streets that are higher traffic areas that should be higher priority. They agreed patch work would be best for now. There is a bridge in town they would like to see redone before resurfacing streets.

Correspondence: Council decided to approve CD Farms LLC to have rural water as it is not in city limits.

Unfinished business: Mayor and council discussed tearing down the Bridie's building on Main Street. City Clerk advised them we would not be able to get any grant money until after February 2025. Council discussed fear of it falling and hurting another building or the possibility of it falling and hurting a person. Council reviewed bids for tearing it down. Motion was made by Hemer and seconded by Duff to accept Bedrock Gravel's bid to tear down the building. Hemer then motioned to amend the original motion to award the bid to the contractor who could complete the demolition first due to the dangerous condition of the building and cost difference being minimal. Motion was seconded by Stuhrenberg. Three ayes.
