# Potential Board Member Open Seat

Mrs. Sands discussed the board member seat that will be opening due to the forthcoming resignation from Board President, Justin Engelland. The Board would need to decide if there would be a full board or select members of the board appointed to a committee to conduct the board member interview process. The Board planned to have two to three special meetings with the full board to search for candidates and conduct interviews. The Board reviewed the interview documents and discussed the interview process. Future meetings would be scheduled for July 12 and August 10.

The Board discussed the requirements for a community member to join the board. Background checks are not conducted. Tiana Adams, Board Clerk would conduct a basic check of the sex offender database to ensure none of the applicants are registered.

Mrs. Sands questioned if anyone would be interested in the role of Vice President. Mrs. LeVert expressed interest. There would need to be a member to fill the secretary position if Mrs. LeVert is nominated to the position of Vice President.

#### **Legislative Priorities**

Mr. Kirar introduced John Noble, District 115 Board of Education Member that serves as their Ed-Red Liaison representative. He discussed the three resolutions the board may present if they choose. The resolutions were Funding for School Security, Special Education Funding and Task Force, and Mandates Review Committee. District 115 would be submitting these resolutions for approval, the goal is to have all three districts; 65, 67, and 115 aligned on what they would submit for state approval. Discussions were held on the resolutions. The Board agreed to move forward with the three resolutions and an action item will be presented to the Board in a future meeting.

In the 21 - 22 school year, Dr. Montgomery focused on the Entry Plan Goals, Superintendent's Entry Plan, Connecting with Community, Getting to Know Our Students, Year One Key Learnings, Scaffolding Progress, Building a Culture of Trust, Cultivating a Shared Vision for the Future, Portrait of a Learner, and Meeting Student Needs in Academics, Life, and Wellness. In the 22-23 school year the focus would be on Updated Strategic Plan with our Portrait, Analyze Innovative School Site Visits, Evaluation of Math and ELA Curriculum, and Cultivating a Culture of Trust and Success for All.
