

Content Warning: Sexualization of minors ment

Two of the allegations made against me are liking a tweet/post of a sexualized cosplay of Serena from Pokemon XY and lying about a certain Twitter user. I do not remember any of these, but if anyone has found the tweet/post about said cosplay and proof of the lie, please show me. I will gladly apologize. If you want to know who is the Twitter user I allegedly lied about, please tell me and I will DM.

Recently, I have been accused of harassing people for their ships. Furthermore, I might have also been vagueposted about to have liked a post of a cosplay of Serena from Pokemon (a minor) that is meant to be sexy, lied about a former mutual to his friend, and also digged for someone's private account. I assume these vagueposts are about me because the mentioned age of the person matches mine, the same person was said to be harassing his friends for their ships, was a snitch for finding out about someone's private account, and that they are acting more morally correct.

I have approached two different people about two different ships. The first is about Serena/Gloria. Serena is implied to be at least 16 because Emma is 16, and the protagonist of the game is said to be a little older. Leon took the gym challenge at age 10, and it's said that he was around the same age then as Gloria/Victor are in the game, and she looks younger than Hilda (who is 14 during BW). The second one was about Ferriswheelshipping/Isshshipping. A mutual of mine (a minor) expressed discomfort from people who share art of these ships. Art of these ships, with or without context, can be used by people for grooming. However, my former mutuals said that these were AU versions of the protags, for whom they have age headcanons, many of which have been with them since they were children. Gloria was apparently around 13-14, and since they set SwSh to have happened around BW, she would have been the same age as Serena by the time of XY (which is set by them to happen at the same time as B2W2, which is two years after BW). I disagreed with them, siding with my mutual who has expressed discomfort.

As a result, I hardblocked people, including longtime mutuals. I have softblocked people who might side with them. This led to a former longtime mutual DMing me, saying that I should have explained why I blocked her and I should have told her beforehand that I was planning to block, that I have made a racist comment of her comparing her to Infernape after I blocked her because she is Indian, and that minors are not always correct. I am apologizing once more for the Infernape comment. Comparing people of color to a monkey was insensitive and thoughtless, and I should not have made such a comment. I have since then deleted the post from my Tumblr.

From her tweets, I can assume that she was upset I have blocked her for the Ferrishweel/Isshu ships, and that she is upset at my mutual for assuming it was pedophilia. She argued that it was a form of projection or selfship, and she changed the skin color of Hilda to make her a different person from her and that she does not have the artistic capabilities of making an OC instead. While I agree that selfshipping is okay, projecting into a character who is canonically a minor and reblogging or retweeting art of it with the said minor is still harmful because even though the artist could be not a pedophile, these types of art can be used to groom people into believing that adult/minor relationships are moral.

The harassment accusations from many people from the protag community may be from how I phrased my responses towards the Serena/Gloria shipper and the Ferris/Isshushipper and also how I phrased my vagueposts about the issues in my "claude screams at people" tag on Tumblr. I was very direct; however, I remain on what I stood for.

Recently, I also found out that someone vagueposted a person for liking a cosplay of Serena that is meant to be sexy. Furthermore, he vagueposted that the same person lied about him to someone. As said earlier, I assume the person being vagueposted is me because the same person has apparently harassed his friends, acts more morally correct, and is aged 19. I have no clue of what the cosplay tweet/post is, or what the lie was about. Should I find out about what these are, I will gladly apologize. However, I do not expect any forgiveness because I understand how much these could have hurt people.

I have also stumbled upon the NSFW account of a popular artist while looking through someone else's follows. This popular artist is one of those I blocked because of the ship issues. I found the @ handle of the account suspicious because it refers to a ship between two minors. Furthermore, the art for its header and the text on its bio are innuendo jokes about the said ship. Besides those, I found out that the artist of the PFP of said NSFW account draws NSFW of the Pokemon protag girls. As a result, I posted about it on Tumblr and on private Twitter. I do not believe this was obsessive or creepy in any way because I found it in someone's follows, which are public.

I hope this is sufficient explanation because I do not want the situation to continue further. I will remain on Twitter, but I understand why the protag community does not want anything to do with me anymore.
