Whereas; Executive, Legislative and Judiciary workers are paid on several arbitrary pay scales.

Whereas; There is no single document defining public sector pay.

Whereas; Most pay is defined by EO133-06, missing newer positions which do not have defined pay and none of it has been defined in any legislation.

Whereas; Specific roles are overpaid proportional to the amount of work other positions do.

Article 1: Executive Pay

§ 1. The following wages shall apply to the President and Vice President:

Role	Wage (weekly)
President	250t
Vice President	175t

- § 1.1. As directly elected officials, the President and Vice President will be paid bi-weekly to coordinate with the end of their term.
- § 1.2. Any Act which references the pay of the President shall be taken to mean the bi-weekly pay of the President.
- § 2. The following wages shall apply to the roles appointed by the President under the Executive Act, the Chief of Staff and the Press Secretary, paid weekly:

Role	Wage (weekly)
Roles appointed by the President under the Executive Act	200t
Chief of Staff	200t
Press Secretary	120t

- **§2.1.** As executive appointed officials, these roles will be paid weekly.
- §2.2. An official with multiple roles under § 2. shall be paid only for the highest role pay they are entitled to under § 2.

Article 2: Legislature Pay

§ 1. The following wages shall apply to the Speaker of the Senate, Deputy Speaker of the Senate, Senators, and the Senate Clerk:

Role	Wage (weekly)
Speaker of the Senate	175t
Deputy Speaker of the Senate	150t
Senator	150t
Senate Clerk	150t

- **§ 1.1.** As directly elected officials, all legislature pay will be paid bi-weekly to coordinate the end of their term.
- § 1.2. An official with multiple roles under § 1. shall be paid only for the highest role pay they are entitled to under § 1.

Article 3: Judicial Pay

§ 1. The following wages shall apply to the Chief Justice, Justices, and Judges:

Role	Wage (weekly)
Chief Justice	175t
Justices	150t
Judges	125t

- § 1.1. As appointed and confirmed officials, these roles will be paid weekly.
- § 1.2. An official with multiple roles under § 1. shall be paid only for the highest role pay they are entitled to under § 1.
- § 2. All roles listed on the chart in Article 3 § 1 of this bill will be entitled to a bonus per case completed, as follows:

Case Type	Bonus
Pre-Trial	20t

Trial	75t
Supreme Court Case	100t

Article 4: Supervisor Pay

§ 1. The following wages shall apply to the Discord Supervisor, Reddit Supervisor, Election Supervisor, and Election Commissioner:

Role	Wage (weekly)
Discord Supervisor	300t
Reddit Supervisor	200t
Elections Supervisor	300t
Election Commissioner	250t

§ 1.1. As appointed and confirmed officials these positions will be paid weekly.

Article 5: Governor Pay

§ 1. The following wages shall apply to the Minecraft Governor and the Nationstates Governor:

Role	Wage (weekly)
Minecraft Governor	125t
Nationstates Governor	125t

§ 1.1. As an elected official these positions will be paid bi-weekly to line up with their terms.

Article 6: Implementation

- § 1. This bill shall come into effect after the 141st Senate is elected and announced.
- § 2. When this bill goes into effect, the Senate Payments Act will be repealed.
