Summary: Follow the contractual procedures related to elementary

preparation and enrichment program emphasis changes.

Brief Explanation:

The SDUSD-SDEA Elementary Preparation and Enrichment Committee is a joint committee charged with monitoring and implementing the elementary preparation and enrichment program. This circular is a reminder of the provisions related to the preparation and enrichment program that are found in the SDUSD-SDEA Collective Bargaining Agreement.

Below are reminders to help your school site successfully implement its elementary preparation and enrichment program:

Each elementary site must have a Preparation Time and Enrichment Advisory Committee.

Section 8.6.4.7. Each site shall have a Preparation Time and Enrichment Advisory Committee to assist with the operation (i.e. selection, scheduling, problem solving, etc.) of this program and to maximize the preparation time allocation for each teacher. The Committee should consist of the principal, the association representative, enrichment teachers and other(s) the site deems appropriate. (SDUSD-SDEA Collective Bargaining Agreement)

Each site must have a Site Governance Team that, among other duties, must approve a change in prep time subject emphasis and the elimination of positions.

Section 8.6.3. Requests for change in subject emphasis for the following year shall be determined by the shared decision-making process, shall be submitted to the Preparation and Enrichment Committee by January 26 and shall be considered in accordance with the district preparation time procedures. Affected enrichment teachers shall be afforded the opportunity to present their views and participate in the discussion prior to the final decision of the governance team. (SDUSD-SDEA Collective Bargaining Agreement)

Whenever a site governance team contemplates the elimination of an existing bargaining unit position, the debate and discussion shall take place at open meetings and affected unit members shall be informed and afforded the opportunity to speak. (SDUSD-SDEA Collective Bargaining Agreement, Section 24.5.1; see also Section 24.5.2)
