# Membership:

- Feedback from Open House:
  - Lots of questions of ways to get involved that don't require a weekly commitment of a league
  - Dirt and cleanliness of ice after open house: sticky matts should be purchased for the club, with visitors if they do not clean shoes they should be asked to go to the bathroom and washed to the best of their ability
  - Membership forms, better explanation of contacting league chairs instead of just checking leagues on forms
- Curling Club Manger is 90% full, past members who have not signed up for this year need to be removed
- How can the club provide more scheduled Open Ice time for members?
- Dave wants to verify a few aspect with the accountant but would like to propose a
  Membership for a Day option for \$20. It would cover members who want to just play

  broom and slider rental.
