The other thing I wanted to highlight. OBTT is another opportunity to catch transitioning service members that maybe were overwhelmed and rushed, just didn't catch everything through the Transition Assistance Program, the TAP program, when they left service. So, that is another opportunity specifically focused on employment that they can catch on the back side of the transition. The services are still having trouble with the transition process. If you read some of the reports lately, there was a report to Congress recently that they're definitely having problems getting those individuals to start the transition process a year in advance. And then they're still having problems getting those folks to attend the training in a time of manner to make it something that they can use and actually act upon. So, there's a lot of work that still needs to be done in that transition process. Thanks to the employment folks that are doing the OBTT as another way to catch on

The other thing – we're still doing CBOC visits. So, I go out to Lynn, Haverhill, and Gloucester once a month, and I do ID cards and assist veterans with enrolling in VA healthcare. I'm still doing those the 2nd Tuesday, Wednesday, and Thursday, from 9:30am to 2pm at each of those clinics. Tuesday is Lynn. Wednesday is Haverhill. Thursday is Gloucester.

The last thing we have on the calendar. We're gonna work. We're gonna have a sorry. I'm trying to look at what we called it, a VSO Orientation last year, a VA Health Care and Benefits Seminar. We made it sound fancy this year. So, what we're gonna be doing is we're gonna be bringing a bunch of different subject matter experts from the different programs within the VA inviting our Veteran Service Officers and organizations to partake in this. It will be hybrid. So, we'll have some people here on site, and then we'll have obviously people out in cyberworld to be able to get information from the subject matter experts. That is gonna be held on Tuesday, January 30. Once I have a flyer and some more information – I don't have a registration link for that just yet – I'll make sure to get it out to everybody. So, anybody and everybody can participate. Hopefully, we'll be able to have some people from Boston/Central Western come play with us as well. And that's all I have pending your questions.

If you submit an event and it says "Veterans Day" in the event, you can actually go to the website and you'll see those events listed at <a href="https://collaborate.vet/veteransday">https://collaborate.vet/veteransday</a> to make it a little easier to keep track of some of

the local events and things that are happening. There's always a lot of lists going around saying, you know, there's free meals in this place and in that place, and they are for restaurant chains across the country. But, this is one way to just kind of circle what's relevant in our place. And, if you go into the calendar and just type in a town name, you'll be able to find events that are specific to that town. But, if there isn't a town in the title listed in parentheses or carved out it's probably an online opportunity for folks. So, just make sure you're aware of that resource because you can use it and share it with others, so that they can figure out what everyone's doing and participate in some of those events.

I'm the outreach guy for the Boston Vet Center. If you don't know the Vet Centers, we mostly provide mental health counseling benefits, assistance for veterans, also their family members and active duty service members. Feel free to direct message me if you have any questions.

So, two things. The first is that we are still continuing to do and offer in person visits for folks that are trying to connect with VBA. We're still doing those monthly. We're actually getting ready to expand and we're probably gonna start offering them more. We'll probably start doing it two days a month because there is demand for it. And, we're gonna be expanding the number of visits that we're offering. So, if folks are having a real hard time getting connected with VBA in a way that feels good and meaningful, they are welcome to reach out to us. I will

say that there is a waiting list for it, but I will continue to schedule people as they are getting interested. But, these are really good. The guys that we have coming from VBA are all senior level that are helping people navigate and figure out the best way to fix their claims. In some situations, the VSRs have been able to type in the veterans stuff directly and be like, "Oh, that's wrong," and like, fix stuff immediately. So, there's some goodness happening there. Folks are welcome to – if veterans are looking to try to set something up like that they should just call us. They can ask to speak to me, and I'll get them scheduled.

In case, I don't know if it was mentioned earlier, so if I repeat this, somebody interrupt me and tell me that everybody already knows. So, the Boston Pop Symphony is gonna be doing their kickoff for their season November 30 with an all veterans and active duty service members and their family concert that is exclusively just for them. There are tickets to be had for it. There was some stuff and some flyers that were going around. And, I think it's my fault because I circulated information, and then it was supposed to. There was supposed to be some like internal stuff.

**Lisa Ducharme:** As I said in the chat, this is National Veterans Small Business Week and Governor Healey did sign a proclamation. It's important to note that Veterans Small Business Week is actually for your veteran, your active, your guard, your reserve, and your military spouses. That's the way the SBA has it written out, which is why Governor Healy, when she signed her proclamation, it was veteran and military spouse. Military spouse is veteran/military spouse. They just say military spouse even though includes veterans. Please let them know about us out at the Massachusetts Veterans Chamber of Commerce because we have some challenges with

veteran businesses. Actually, right now, there's a 3% set aside. But, it's not a requirement. It's a "you can." So there's no requirement for the 3% set aside for our veteran businesses for contracts. It's a good thing to do. They can say they have a 3% but it's not a real 3% because it's not required. So one of the things that we are challenged with is the fact that we don't have very many veterans that are actually certified. But, also the numbers of veteran businesses have really been skewed over the years. We're currently working on a census to collect all of the information for all of our veteran owned businesses. In 2007, the Census Bureau said that we have over 53,000 veteran owned businesses in the state of Massachusetts. In 2012, the Census Bureau said that we had over **52,000**. 2015, same thing, 2000, **28,299**. If we had that significant of a drop, we have a big problem. So I wanna see, was there a change in the Census Bureau? I've reached out to the Census bureau to ask the questions. The different people I've talked to said, well, there was, but it wasn't enough to change those types of numbers. Is there really a problem with the veteran businesses in reference to the identification? So, what my goal is with the Massachusetts Veterans Chamber is to get all the information from our veteran businesses, create the database that nobody in the United States has. They do not have to be certified to come into the veterans chamber if they don't want to join the chamber and it is free. But if they don't want to join, and they just want to give us their information, we will just take their information. And when people reach out to ask for a veteran business we can give them that information.

We have our Morning Coffee Hours every Wednesday morning. One thing I will say is that every morning, every Wednesday morning, I actually have a checklist. That checklist does not go out to anybody except those who attend the Morning Coffee Hours last week. I did answer the public this week, I did content management or content mapping for social media. So, it's good for businesses as well as anybody who happens to do anything in their organization. So, I just wanna bring out cause our goal is to help our veteran businesses out there. Right now. We have cookie cutter type of assistance for them, and we have a lot of organizations within our sea of goodwill. The problem is, our businesses don't even know about even civilian businesses. Don't know about a lot of the resources we have in Massachusetts, and the 2 books that I put in the chat. They're free until Friday for National Veterans Small Business Week, even if you don't want them, I'm gonna recommend you download them. This one right here has over 100 skills and lessons we learned in the military and tells you how we use it and then the other one, that we are stronger together. This one right here has a bunch of business re buzz, bunch of business information, and 22 veteran military spouse businesses who provided their input both have a ton of resources.

And of course I'm all about resources. Right? So, I just ask everybody, if you know anybody, please shoot them our way. If you know any businesses that need help, I cannot tell you how many places we have in the state of Massachusetts that when we did our soft launch on October 11 they had not even talked to each other. And I'm like, okay, we got these problems. But, I do want you to know that I have shared everything. And especially that calendar cause I love that calendar. I've shared that with both the Worcester and the VOICE down here in Western Mass and I've asked everybody to use it. It's not, you guys haven't made it so that it's only for Boston. You've made it for everybody. So, I'm trying to get people to use it. I have 2 businesses who are trying to start a business because we don't have the tools for people to know what's going on. I said, I sent both of them to that first, and said, before you do anything, look at this and, Bob, as you know, I sent the Secretary your way, saying, Hey, you guys have this calendar. You guys have all these great resources and you know I need everybody to come together underneath one umbrella, so that we can kind of put it all together and make life a little bit easier for people. Rachel McNeill: Yeah. So, I actually have a request. Last month we talked a little bit about some of the data in Massachusetts with veteran suicides and overdoses and how Massachusetts does have this data available. If you had missed that, essentially, the most recent numbers that are available for both, for Massachusetts, are released from the Data Injury Surveillance Program that Massachusetts has. There are, off the top of my head, we had 67 suicides in 2019 and 90 overdose deaths in 2019. And, we're trying to figure out if anyone knows when Massachusetts will release the 2020 data sheet for overdoses. If that's anticipated to come out. We'll keep kind of looking around and see. But that may be helpful just in thinking about some of our future plans, for when we you know, we may want to put that information out to folks and help think about that and ways to increase safety for veterans and service members. So if anyone does have that, you can either email us or post it in the slack otherwise we'll report back if we track it down.
