



MainStreet Maker's Market Food Truck Agreement

1. By signing and paying the space fee, you accept and will follow the rules of this contract and the Market Rules and Policies available online and in print. Fees are \$50 per space per event for food trucks.
2. Contracts and payment (payable by cash, check or card) must be signed in advance and payable to Clovis MainStreet non-profit a minimum of one day prior to the day of the event. All payments are non-refundable, credit will not be given for no-shows as funding is used for marketing efforts, event resources and management.
3. Food Trucks must provide a copy of their Clovis business license, NM food permit and Insurance. (Once provided we will keep it on file for future events, please remember to provide an updated copy when they expire.) Seller is responsible for collecting any applicable sales tax and must meet all city and state business permitting or licensing required for their business type or products.
4. Space Assignments and Times; Space will be assigned by the event organizer and done on a first come basis and filled in order to avoid vacant spaces. Vendors will need to be in place and open from 11am to 7pm, early move out will not be possible, food trucks are allowed to continue service till 9pm if they desire.

Vendors can load in and begin setting up two hours before opening time of the event. Vendors are responsible for leaving the area in the same condition as they found it and must empty the trash within the food truck area and provide their own equipment for any additional needs(i.e. generators, canopies, extra tables, etc.). We reserve the right to refuse any vendor. Electricity is limited and will need to be requested in advance and limited to a first booked basis. All vendors must have the required business license and health permits to operate in Clovis, NM and provide a copy when booking. Vendor insurance must also list Clovis MainStreet/Curry County as additionally insured and copy provided. No overnight security will be provided and all vendor trucks must be moved from location.
