
Abstract**Adaptive Livelihood Strategies: A Micro-Level Analysis of Women's Resilience in Post-Coup Karen State****Nan Khine Cho Cho Thin**

In this study, researchers examine how the 2021 military coup affected Karen women's economic and living conditions, specifically their financial autonomy, freedom of movement, and access to support networks. This study was conducted through a qualitative approach to understand women's resilience and coping strategies regarding their micro-level livelihood in the post-coup of Myanmar. Key informant and semi-structured interviews were conducted with 10 women in Kayin State, especially Hpa-An, Myawaddy, and Kawkaareik townships. Purposive sampling and snowball sampling also included in this study.

The study found that before the coup, women were engaged in family businesses, entrepreneurship, and vocational training. The freedom to engage in economic and social activities was considerable. However, in the post-coup period, political instability has limited women's access to economic opportunities and suppressed their voices. Women have faced severe movement restrictions, financial turmoil, and a breakdown of external support, which have greatly hindered their ability to earn a living. Many women have become indebted due to rising raw material costs, and restricted market access.

Although women have adopted adaptive strategies, such as changing business models for family businesses, they remain financially vulnerable without fully supported job opportunities and policy interventions. Furthermore, displaced women face economic hardships as a result of housing insecurity and financial constraints. Targeted economic support mechanisms are urgently needed to increase women's resilience to political and economic turmoil in Karen State.
