(PHONE RECORD CONTENT OF MY CELL WILL PROVE) THE POINT I AM TRYING TO GET AT, IS THAT EACH YEAR IN FEBRUARY, ONE OF THE COLDEST MONTHS IN MINNESOTA A SCHEME UNFOLDS.
