

Trade-for-Print Agreement

Scope of Work & Compensation

This contract is for services and products related to a Photography Shoot (hereafter "shoot" or "the shoot") to take place at the following date and location:

| This contract is a non-commercial agreement where the model, |
| images (hereafter "Images") delivered to them by Ma'iitsoh Yazhi Photography (hereafter |
| "Photographer"). These Images will be culled from the total of photographs taken during the contracted session, which at the Photographer's discretion, best mutually benefit and exemplify |
| the talent of both the Photographer and the Model. |

Delivery shall take place in a timely manner, and where possible, delivery is to be made within 120 days after the date this contract is signed by the Photographer. No minimum number of Images are implied or guaranteed by this contract. This delivery constitutes the whole obligation of the Photographer towards the Model.

Image Production and Use

The Model understands and agrees that copyright, moral rights, and all other intellectual property rights to the Images belong to the Photographer and/or his heirs, licensees or assigns, with the full right of lawful disposition in any manner. The Model agrees that the Photographer may combine the Images with other images, text, graphics, film, audio, and audio-visual works, and that the Images may be cropped, altered or modified. The Model further agrees that the Photographer may use, re-use, publish, and republish the Images, intact or in part, composite or distorted in character or form, without restriction as to changes or transformations or reproduction in color or otherwise, made through any and all media now or hereafter known.

The Model also agrees to release, discharge and agree to hold harmless the Photographer, his heirs, legal representatives or assigns, and all persons functioning under his permission or

authority, or those for whom they are functioning, from any liability by virtue of any blurring, distortion, alteration, optical illusion, or use in composite form whether intentional or otherwise, that may occur or be produced in the taking of said picture or in any subsequent processing thereof, as well as any publication thereof, including without limitation any claims for libel or invasion of privacy.

The Model agrees that his/her personal information will not be made publicly available but may only be used directly in relation to the licensing of the Images where necessary (e.g. to defend claims, protect rights or notify trade unions) and may be retained as long as necessary to fulfill this purpose.

Promotion and Credit

The Model agrees that, while he/she may use the Images for purposes related to the promotion of the Model's modeling business--including, but not limited to advertising, portfolios, composite cards, exhibitions, contests, and promotional web sites (including paid-access sites, such as Patreon, OnlyFans, etc.)--the Model will not attempt to sell or otherwise transfer publication rights to any of the Images without the Photographer's prior consent.

The Model understands that the Photographer has the moral right to be identified as the author of the Images when copies of the Images are presented, and shall communicate this understanding to publishers, designers and other third parties that act on Model's behalf to create presentation material using the Images. Any watermark, copyright notice or EXIF data that appear as part of the Images must be left intact.

Likewise, the Photographer understands that Model has the moral right to be identified as the model in the Images when copies of the Images are presented to the public, and shall communicate this understanding to publishers, designers and other third parties that act on Photographer's behalf to create presentation material using the Images.

Liability and Release

The Model releases and agrees to hold the Photographer and/or his heirs, licensees or assigns, harmless from any claim or liability in connection with the publication or use of these images in any manner or form whatsoever, unless it can be clearly shown that the foregoing was maliciously caused, and produced, and published solely for the purpose of subjecting Model to conspicuous ridicule, scandal, reproach, scorn, and indignity.

The Model hereby affirms that all poses, positions and situations enacted in the Images covered in this release were entered into without force, coercion, or threat whatsoever, and were posed

freely by the Model with his/her full consent. The Model further agrees to hold the Photographer blameless and free of all accusations of such force or coercion.

Publication and Platform Restrictions

The Model will have 30 days from delivery of the Images in which to review the images provided by the Photographer, after which the Model may limit or decline release of any or all provided files. For any Images of which release is limited or declined, the Model also relinquishes the same rights to those Images as granted in Section 3 above (though Model may still retain unreleased images for personal use only). Failure of the Model to respond within 30 days shall default all provided images to this agreement.

By default, the Model restricts publication of images from this shoot to ONLY the platforms listed below.

Publication Restrictions:

Both Model and Photographer agree to credit the Photographer in any released image using only the following name(s):

Both Model and Photographer agree to credit the Model in any released image using only the following name(s):

Both Model and Photographer agree to credit any rope work in the released Images (if applicable) using only the following name(s):

Both Model and Photographer agree to credit any other assistants (such as hair, makeup, costume, or general assistance) in the released Images (if applicable) using only the following name(s):

Released Images may not contain the following identifiable portions of the Model's face and/or body:

Signed Verification

The Model hereby warrants that he/she is of full legal age and is fully able to enter legally into contract in his/her own name without breach of any prior agreement or applicable law, including, but not limited to, prior agreements with modeling and talent agencies.

Both Model and the Photographer affirm to have read the above authorization, release, and agreement, prior to its execution, and are fully familiar with the contents of this document.
