



After submitting registration, students/parents must complete all supplemental forms by the listed deadlines.

NSD does not broker, sell, or advise on insurance policies or services. However, as with any travel/activity plans that involve commitment and expense in advance, you might consider acquiring an insurance policy to protect the value of your camp registration and surrounding travel plans. After reviewing the Payment Terms & Conditions, you can assess whether an insurance policy might fit your needs.

1. 30% of your total required payment is a non-refundable deposit. **This deposit cannot be refunded under any circumstances.**
2. After February 1st, any cancellation will require that 45% of your total required payment is non-refundable. Any outstanding balance is still required to be paid.
3. After March 1st, any cancellation will require that 60% of your total required payment is non-refundable. Any outstanding balance is still required to be paid.
4. After April 1st, any cancellation will require that 75% of your total required payment is non-refundable. Any outstanding balance is still required to be paid.
5. **After May 1st, any cancellation will require that your total required payment is wholly non-refundable. After May 1st, no refunds of any amount will be given. Any outstanding balance is still required to be paid.**
6. With the exception of students who have already registered or students who have applications for registration pending and in good standing, the price of NSD is subject to change without notice.
7. By choosing to submit a registration for the camp you have selected, you agree to pay the amount required for registration.
8. If a student chooses to leave a session early for any reason, or is asked by NSD or our college/university hosts to leave early for any reason, the parent or guardian identified on the registration forms is responsible for the full expense of travel costs, as well as for supervision of the student upon departure. In this event, no refund of your total required payment to NSD will be given.
9. Students agree to follow all rules and instructions given by NSD and its staff, as well as by our college/university hosts.
10. If a student arrives at the airport as an "unaccompanied minor," and requires that NSD (as opposed to a family member or local relative) to pick them up from the airport, they will be assessed the "faculty accompanied transportation" service fee. This fee is necessary, as faculty transport of students is very demanding of staff and entails staff arriving earlier and staying later to camp. You will not pay this fee as a part of the registration process; the fee will be assessed later when we collect travel information from you.
11. Registrants for online sessions are responsible for providing a computer and an internet connection that will support online conferencing and video calls in accordance with NSD specifications. NSD will not be responsible for technical issues arising from the participant's inability to connect or a participant's scheduling difficulties.
12. Registrants for an in-person session may request to switch to an online session at any time. NSD may honor this request at its sole discretion. In the event of a switch, registrants will not receive a refund of any difference in tuition between in-person and online sessions in excess of any refund the registrant would be entitled to upon cancellation.
13. The locations of in-person sessions are announced by NSD. The announced locations may be changed by NSD, within its reasonable discretion, to similar locations in the area at any time prior to the commencement of the session. No refunds will be made in connection with announced in-person locations, or in connection with changes to those locations announced prior to the commencement of an in-person session.
