Prologue:

This document comprehensively goes over numerous allegations of Parlo [Tobias] inappropriately engaging with 5+ minors while he was an adult, some who are significantly younger than himself, discussing topics like self harm to minors which is illegal, sending sexual content and even discussing real life violent topics. While also addressing Tobias's long history of lies and manipulation to downplay his actions. This document substantiates many of these allegations.

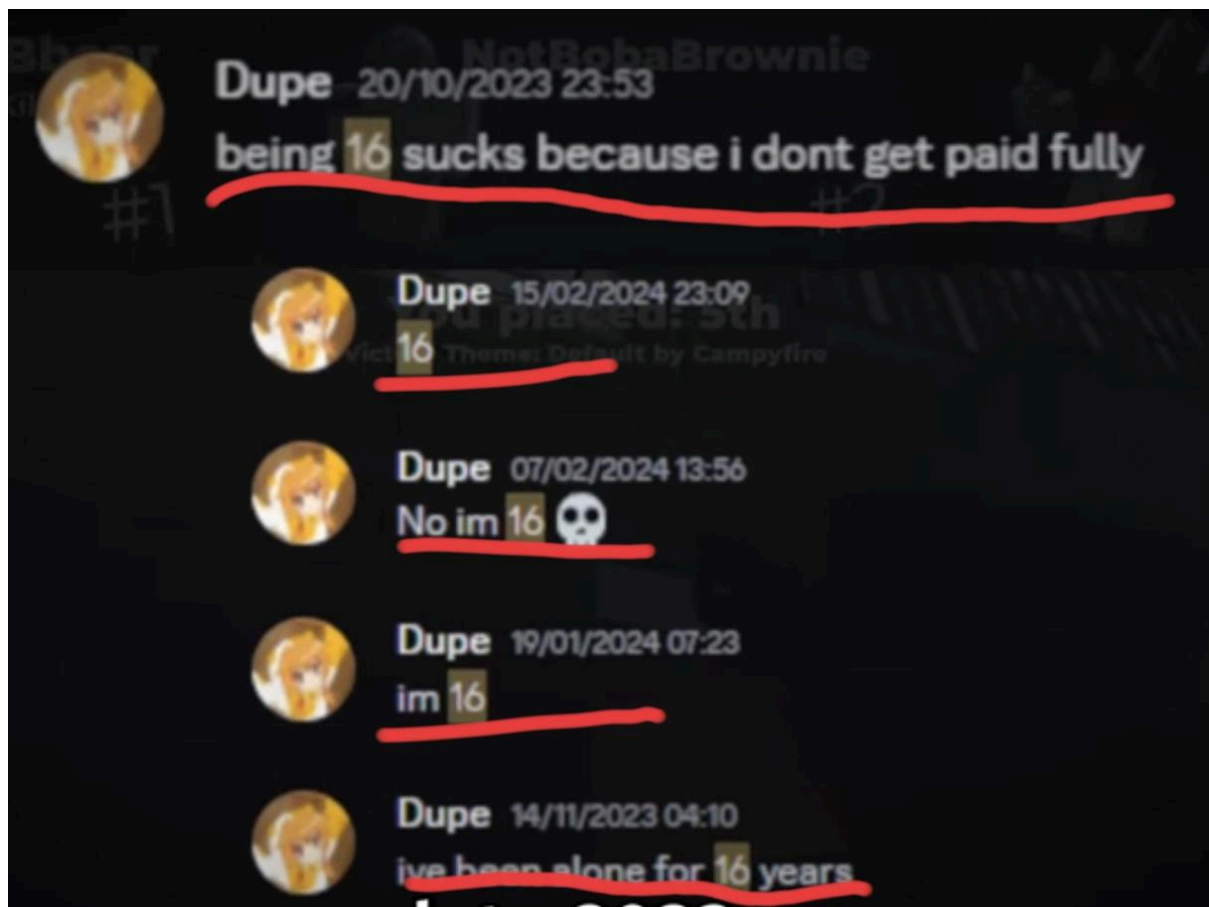
This document proves that Parlo continued to engage in sexual erotic roleplay [ERP] with a 12 year old boy named Solomon/Dupe while he was 19 until they were 13 and he was 18 while knowing their age.

Parlo engaged in sexual discussions and had continued to send Self Harm/NSFW to Dupe from 2024 spanning to January of 2025 which is illegal, admitted to asking for NSFW art of the minors and also discussed the idea of commissioning NSFW art & fetish art of their sonas.

Solomon/Dupe:

Dupe, aka Solomon/Soul, met Parlo back in 2023.

Parlo claimed that Dupe lied about his age previously and that he didn't know his age and uses this screenshot to prove it -



Now, I will like to obliterate the fact that Parlo didn't know Dupe's age, since Dupe had already clarified it to Tobias in a message.



Parlo himself [confirmed that he knew Dupe was 11-12 and yet continued to date him](#) when confronted by another YouTuber "[Saythe](#)".

And before he claims that the audio call was manipulated or fabricated, it's impossible to fabricate a discord call since it's a call being RECORDED, especially a [Discord call where you admit to dating a 12 years old while knowing their age.](#)

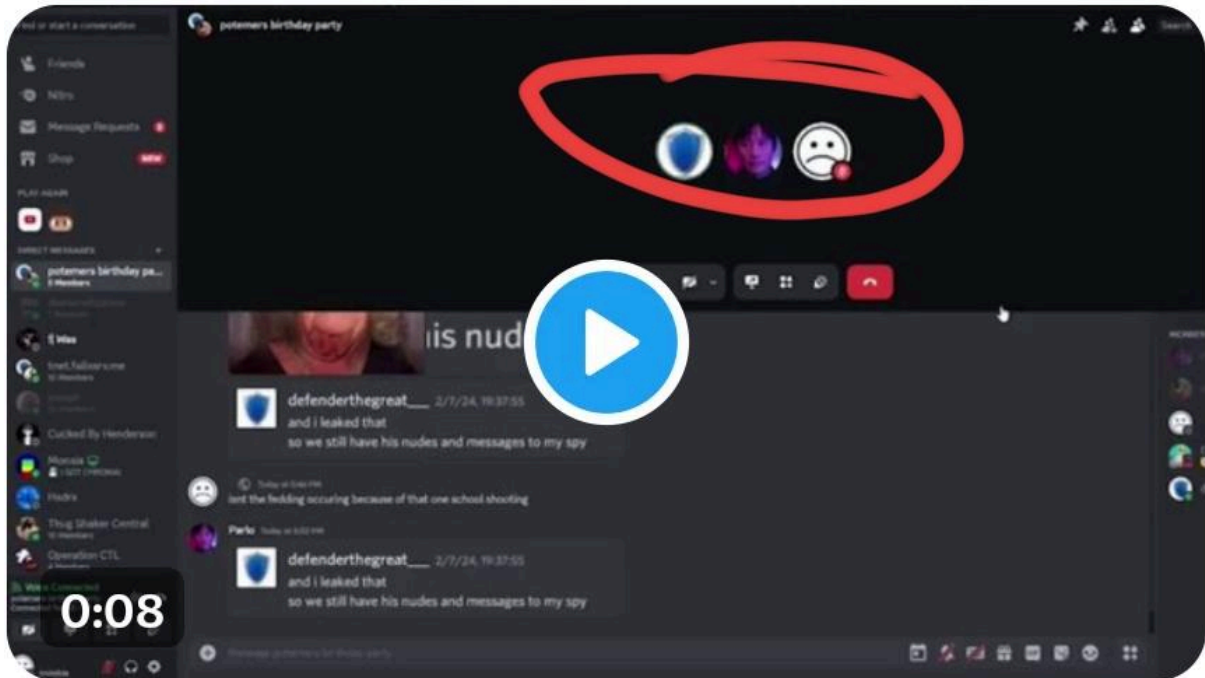

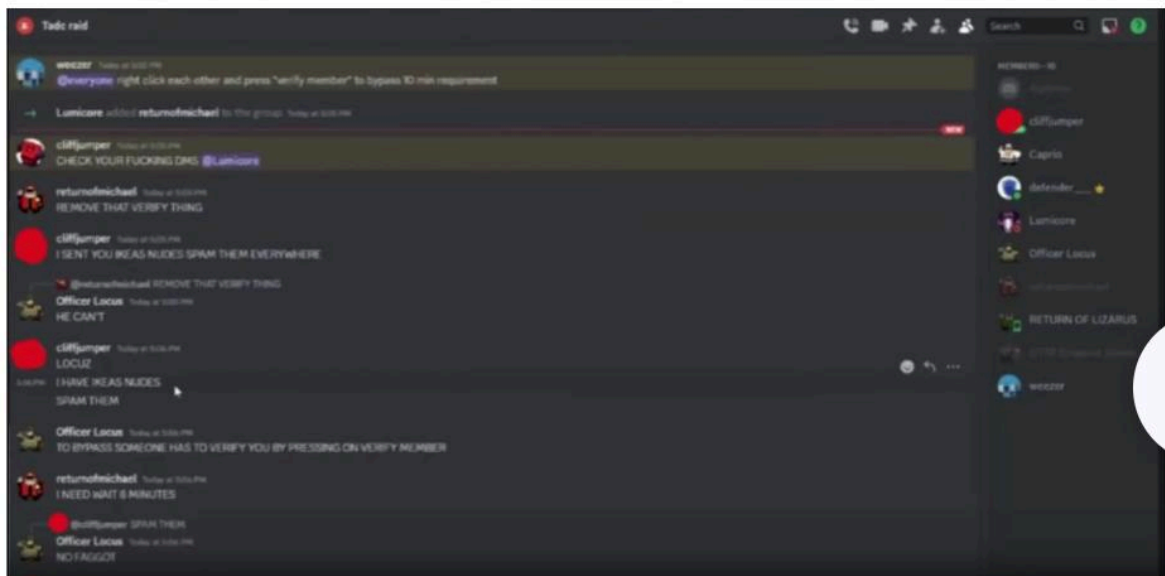
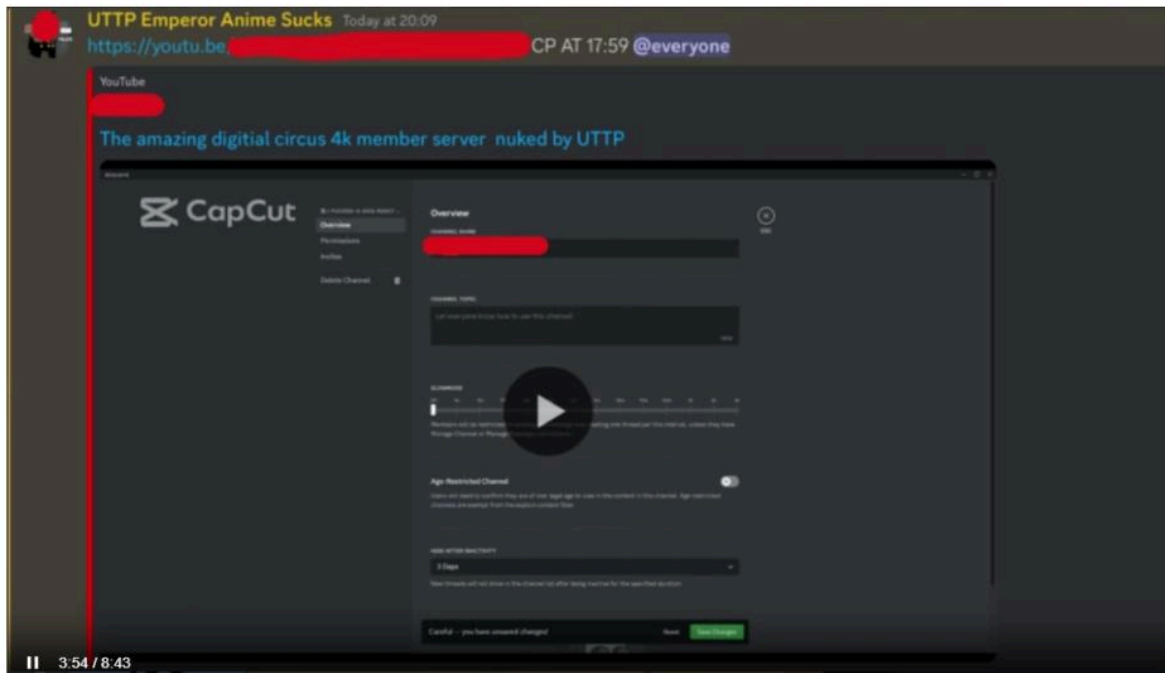
Defender is someone who Parlo associates with actively and is seen in numerous discord calls with Parlo.

Defender had groomed a 16 years old called "Ikea", who's the leader of a [Murder Drones](#) fandom group.

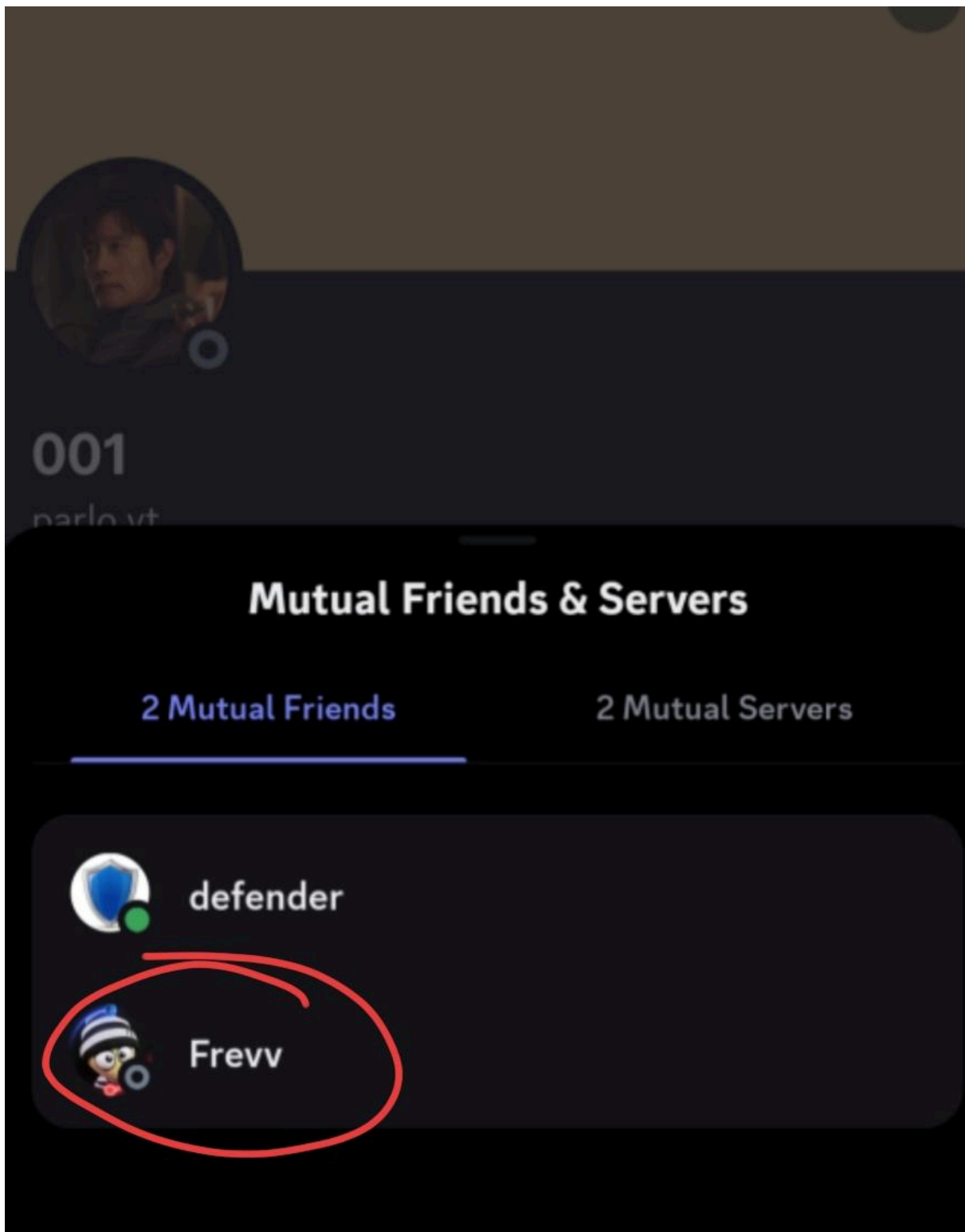
Defender had gotten his goons to do a raid where he would spam Ikea's genitals images randomly in a discord server.



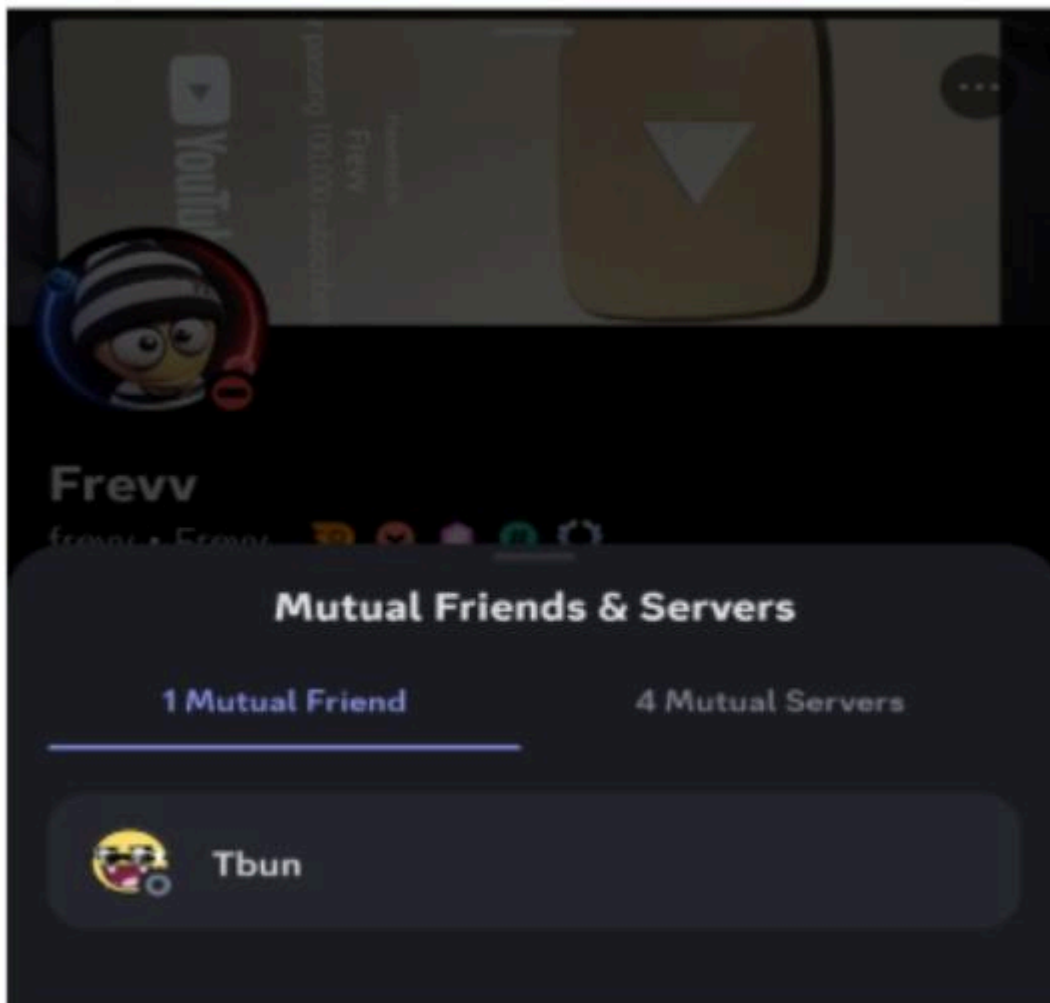

Now, Frevv is seen being mutuals with another Pedophile called "Tbun", aka Terminal Bun.

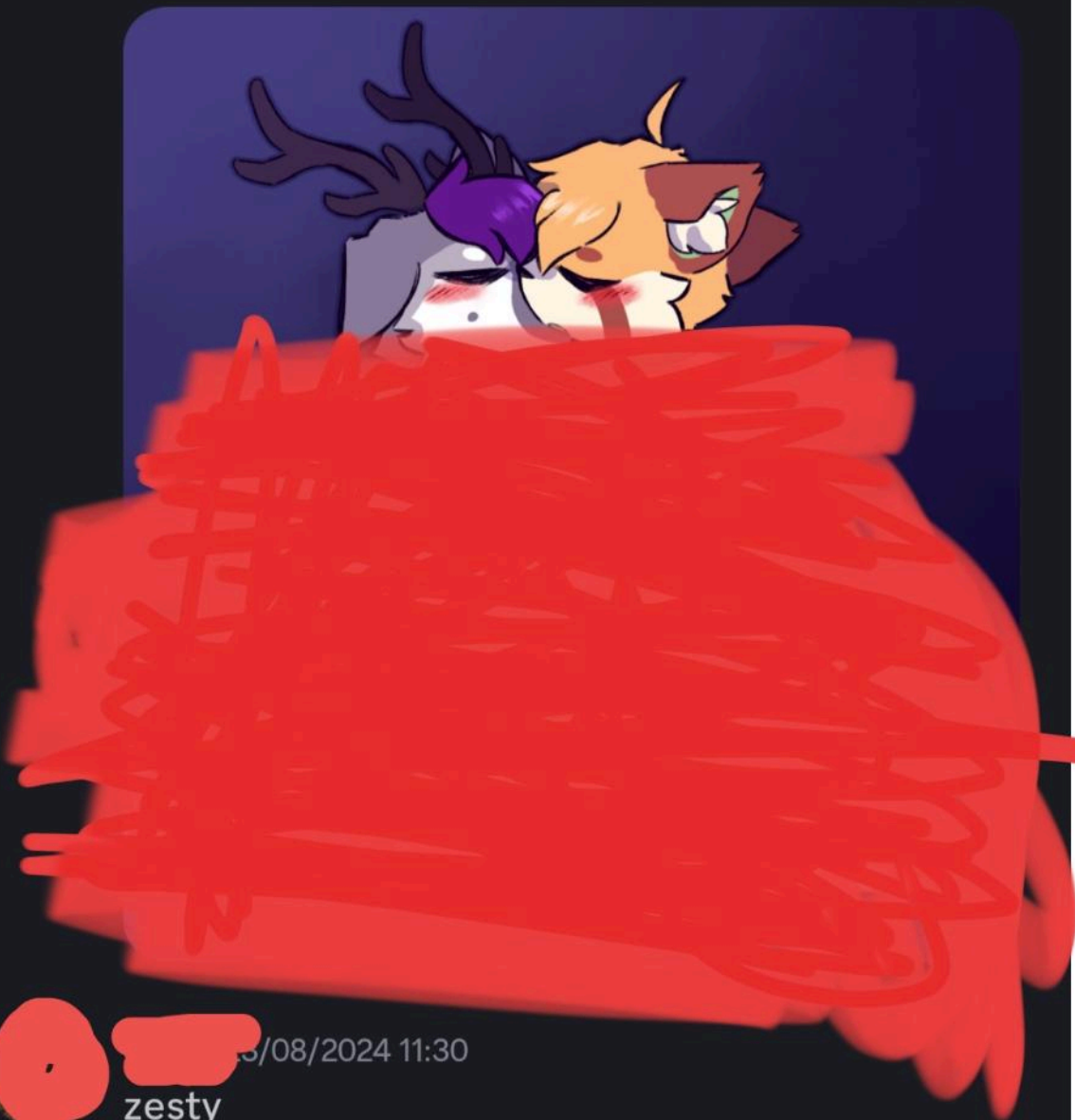


Now, Tbun had asked a 15 years old about their sexual fetish and also had sexual messages with them, Tbun had also said to the minor he wanted to ERP with the minor.

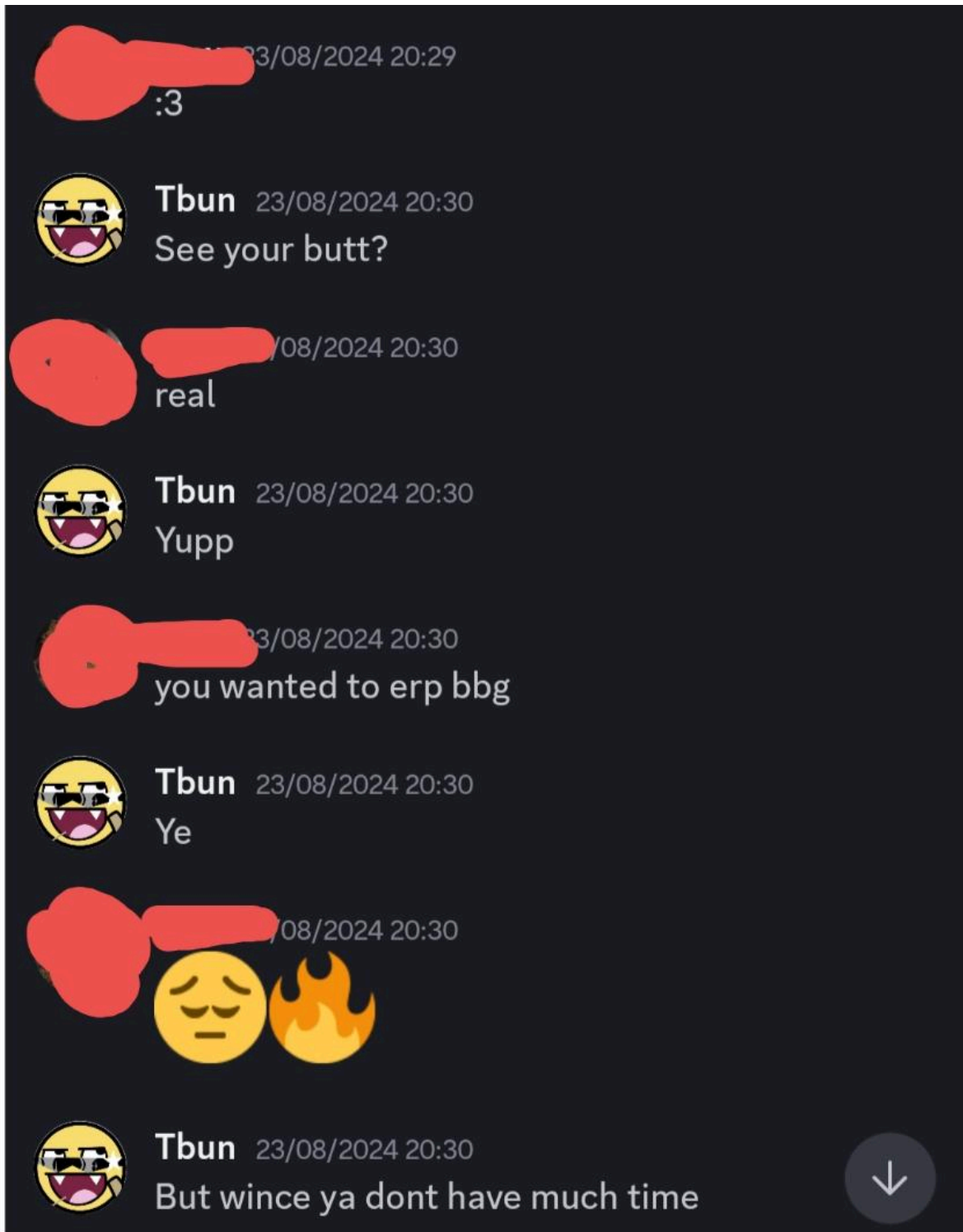

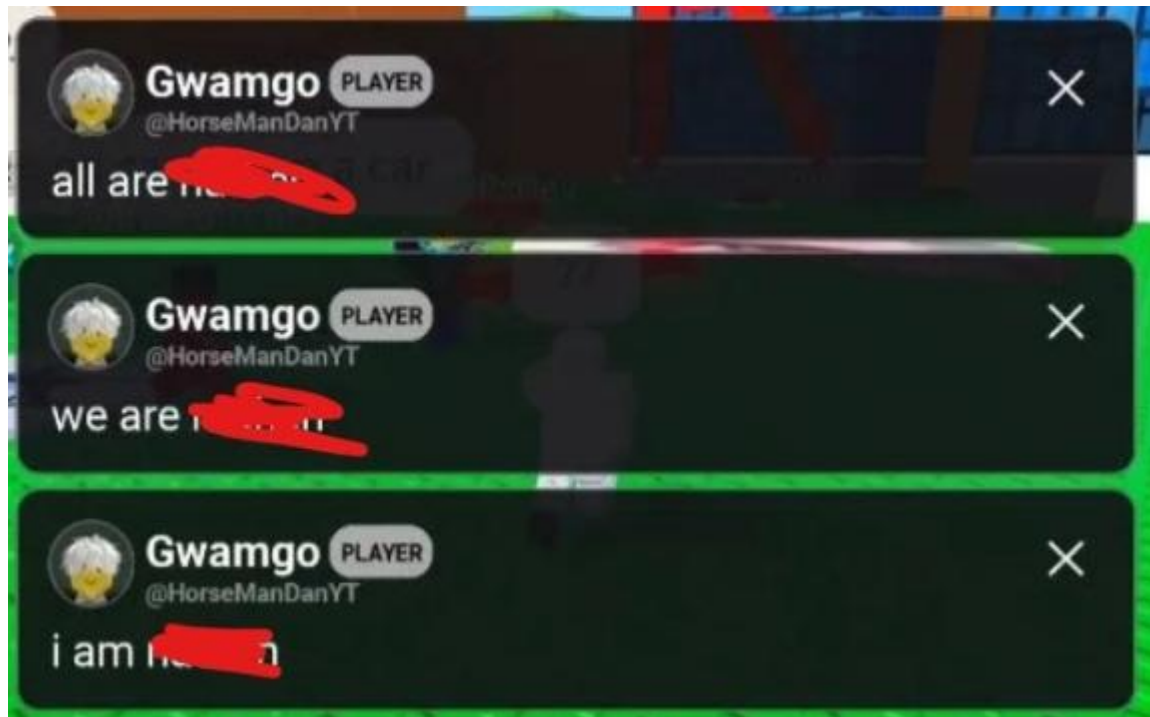

Now that we've proved both of these people follow each other, let's see who Parlo associates with.

RED: A VICTIM:

Gwamgo was seen doxxing a 16 y/o, who we'll call **RED** for their privacy, in Parlo's Roblox game, with the messages - "WE ARE [*Censored*]" "ALL ARE [*CENSORED*]" "I am [*CENSORED*]".

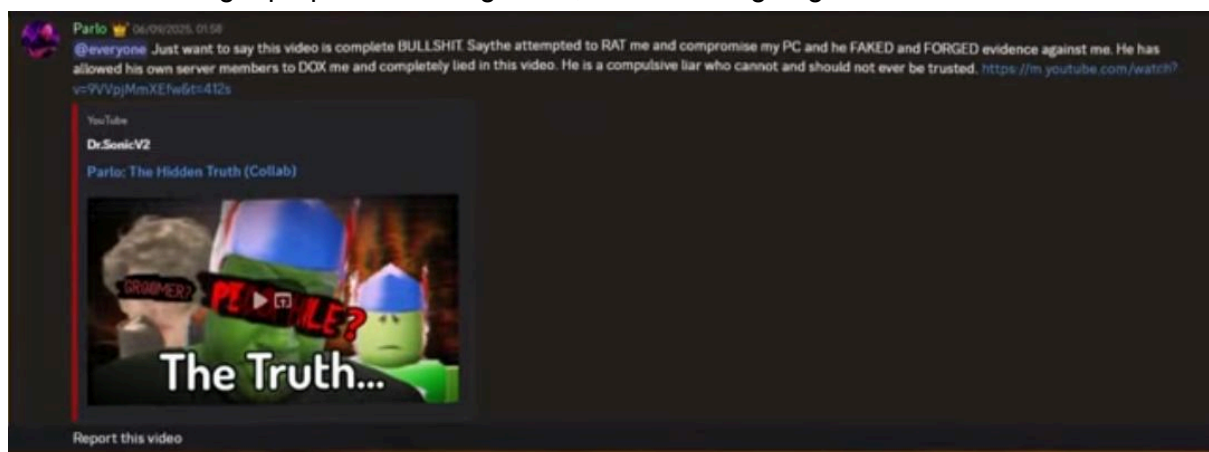


That's not just a regrettable thing, it's a LITERAL FELONY.

Mass reporting of the truth:

Parlo was seen indicating his users in his cord to mass report a video on him made by an individual called drsonicv2.

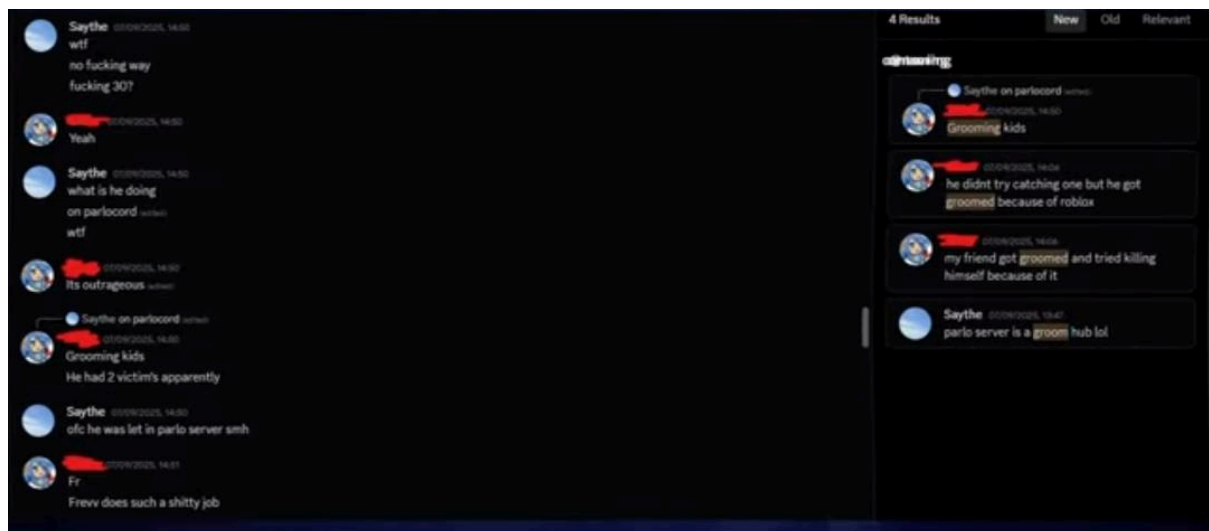
Instead of making a proper debunking video, he chose to go against Youtube's own TOS.



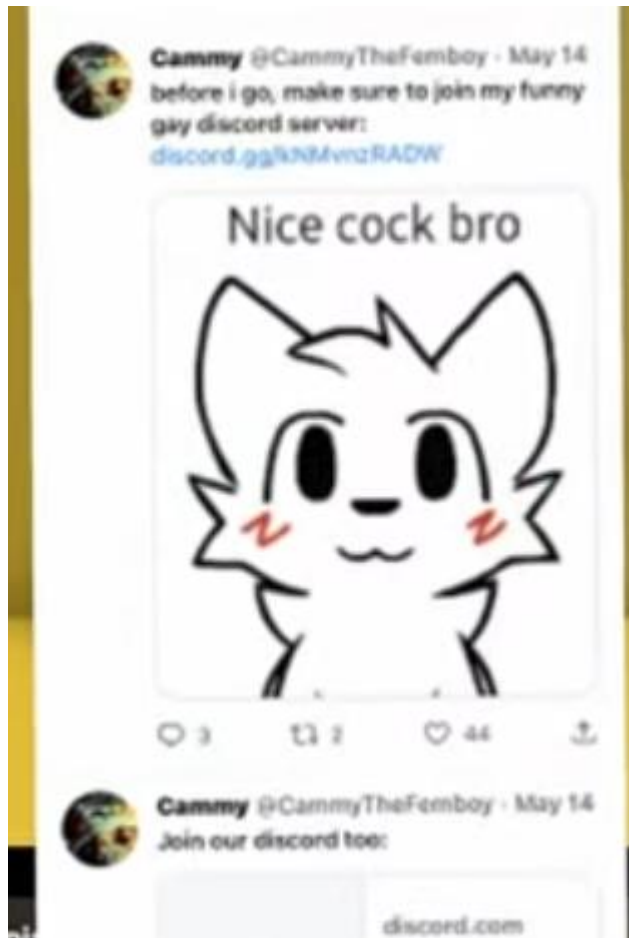
Yes, false mass reporting against YouTube violates their Terms of Service as it is considered misuse of the reporting, flagging, complaint, dispute, or appeals process. Such actions are a form of "circumvention," which can lead to termination of the offending channel and any new channels associated with the user. [Link](#)

Association with PDFs:

According to the YouTuber "[Saythe](#)", one of Parlo's discord staff was accused of grooming, to which he still keeps on his discord.



Not only that, he was also seen posting inappropriate content on his twitter that was originally posted in his discord back in 2023 under his twitter alias "CammyFemboy".



Not only that, he was also seen making false allegations against Pyrocynical claiming he dated a 15 years old while he was 20 called "Ivory", despite [Ivory attesting herself that she wasn't forced to send nudes to Pyro, neither did Pyro solicit nudes from her or had shown his own nudes](#).

Parlo uses this allegation to steer away from his own crimes against dupe, and [actual admissions of him knowing Dupe's age and yet dating him](#).

Piss-play:

Now that we've proven that Parlo knew Dupe's age and yet continued to date him [by his own admission](#), we can now continue with another fetish of Parlo:

"Piss-play".

Parlo was seen making numerous piss play jokes with Dupe, even overriding parental boundaries.

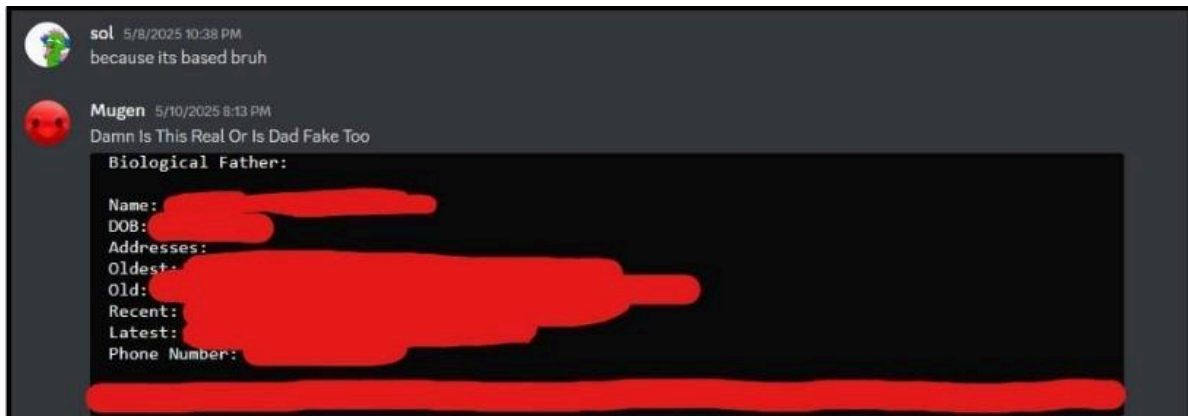

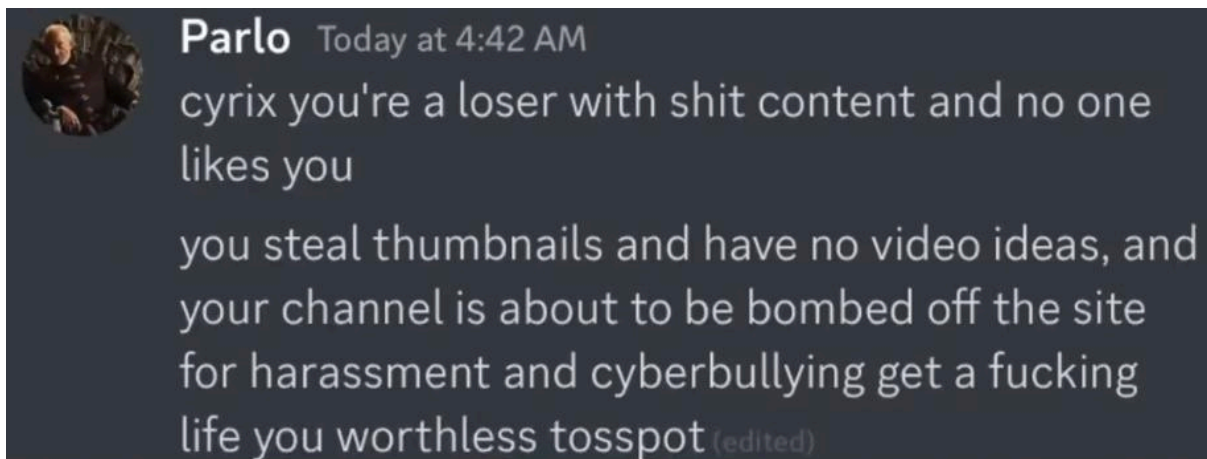
#Image 1 - Parlo and Gwamgo were seen degrading Dupe as a Compulsive liar and attacking his character instead of the validity of the claims.

Not only is this behaviour problematic, it suggests a lack of accountability and remorse for someone's actions, which Parlo doesn't take accountability for any of his actions.

Back in 2023, a creator called [Cyrixwashere](#) made a [video talking about Parlo false striking critics](#), to which he got a "confrontation" (Which was disguised harassment) by Parlo in Discord DMs.



Keep in mind Cyrix was **16** at that time.

Tobias harassed him over a minor confrontation.

Another individual called "Gax", previously known as GMC, made a similar topic video and got harassed by Parlo too.
