Methods: *Describe the community service approach and procedures, including the type of intervention, design, target population or participants, sample size (if applicable), and any methods used to assess outcomes, both qualitative and quantitative.*

Results: *Present the key outcomes of the community service activities. These may include measurable improvements in community knowledge, behavior, skills, or practices; increased participation or engagement of target groups; successful implementation of training, workshops, or health education; development or utilization of appropriate technology; and documentation of community feedback. For quantitative evaluations, include descriptive statistics or relevant indicators. For qualitative approaches, summarize major themes or community responses that demonstrate impact.*

Conclusion: *State the main recommendations and practical implications of the activity. Conclusions must be specific, actionable, and relevant to the target community or stakeholders. Do not include references, citations, or displayed equations in this section.*

INTRODUCTION (Describe in narrative form, not subchapters) (Times New Roman 12)

This section should briefly explain the background of the community service, provide a brief review of related literature, state the originality of the community service, and state the purpose of the community service. This section also includes factual and actual problems, challenges, or requirements needed by the community related to the purpose of community service, as well as solutions that will be provided to the community. Include literature evidence that states the community service carried out is in accordance with *evidence based*, or make an explanation if this community service is completely new.

Use double spacing. Manuscripts must be submitted in .docx, .doc, or .rtf format. The preferred article length is 4000 to 8000 words. Manuscripts must be written in good English and are free from grammatical errors. However, it is strongly recommended to submit the manuscript in English. Make sure the article has been checked with a proofreading tool (e.g. Grammarly) and, if possible, proofread by a language editor. British or American spelling can be used, but do not mix the two. Use Times New Roman font size 12.

METHODS


Combine the methods and procedures used into one narrative section. Sufficient information, at a minimum, includes description of the activities carried out, steps of the activities, objectives, time and place of community service, evaluation carried out, and other necessary information. The same method that has been published must be shown with references and citation. In general, Journal of Empathy adheres to the International System of Units (SI).

RESULTS (Describe with a brief narrative, Times New Roman, 12)

Describe the results of community service. Data should be presented as concisely as possible, and in the form of tables or figures where appropriate, although very large tables should be avoided. If necessary, this section can be combined with the Discussion section into a Results and discussion section. The results of community service can be presented in the form of images or data made into pictures/graphs/diagrams, tables, and/or descriptive. In this chapter, it is not just narrating the contents of tables and figures. Analysis and interpretation of these results are required before discussed. Figures and tables are written in the centre of the column. The title of the figure or table is written from the left above the figure/table, all words are written using capital letters except conjunctions. The distance between rows in the table uses a *single space*. For example, see Figure 1 and Table 1.

DISCUSSION (Describe with a brief narrative, Times New Roman, 12)

This section should be an interpretation of the results of the activity (not a repetition of the results) in the context of the community service carried out. Avoid excessive references to published literature. If necessary, this section can be combined with the Results section into a Results and discussion section. The discussion should explore the significance of the community service results and explain the limitations of the community service implementation. The following components should be included in the discussion: How do your results relate to the original question or objective outlined in the background section (what)? Do you provide a scientific interpretation for each result or finding presented (why)? Are your results consistent with what other investigators have reported (what else)? Or are there differences

CONCLUSIONS AND SUGGESTIONS

The main conclusions of this research may be presented in a stand-alone Conclusion section or included as a subsection of the discussion section. Must answer the objectives of the community service. Provide clear scientific justification for your study, and indicate possible recommendations for future practice

ACKNOWLEDGEMENTS

Acknowledge who contributed to this community service, as well as any funding or grants received to support it. Names of funding organisations should be written in full, along with the grant number, if available. Mention any people who helped you during the study (e.g. assistance with study design or analysis, or guidance through the study area), or writing the article (e.g. providing advice on language, editing, or proofreading the article).

REFERENCE (Times New Roman, 12)

Write references in Vancouver format. References consist of all references used to write the article. Make sure the citations used are as contemporary as possible, including those from the current year of writing. Remove citations of older literature (**more than 5 years old**) unless this is central to your study. References should avoid the use of secondary citations. To enhance scholarly contribution and interconnection within the journal, **authors are required to cite at least one (1) article previously published in**

Jurnal Empathy in the reference list of their submitted manuscript. Authors must include a minimum of **15 references from peer-reviewed journal articles to ensure the scientific rigor and relevance** of the submitted manuscript.
