Give adequate background of the problems you solve. Avoid overly detailed literature review, draw a summary of the results. Explain how you deal with the problem, and explain your purpose. When writing the introduction, make it understandable to non-expert readers in this matter. Use narrative formats and avoid using sub-chapters.

MATERIALS AND METHODS (Times New Roman: 11)

Explain in detail about the research design, time, variable, population, sample, sampling, instrument, data analysis, and information pass the ethical test.

RESULTS (Times New Roman: 11)

The results presented should be sequential from the main results to the supporting results. Use measurement units based on applicable international standards. Can be added diagrams, tables, pictures, and graphs with complete with narration.

Images and tables are placed at the end of the manuscript by following the rules: 1) drawings, tables, and diagrams should be editable; 2) the title of the image and the table is written at the top with times new romance 11, single space; 3) narrative images and tables are written at the bottom of the tables and drawings; 4) table contents using times new roman 10, single space.

DISCUSSION (Times New Roman: 11)

Describe the key points of your findings. Make it as concise as possible but clear. Follow the logical thinking flow. In general, interpret and discuss the importance of your findings in the order in which you describe them in the results section. Use the verb now, especially for the facts that appear. Compare your findings with previous studies. If necessary, use sub points to organize and categorize your discussion. The contents of the discussion include explanation of the results, previous research references, and opinions of researchers.

CONCLUSION (Times New Roman: 11)

The conclusions should be clearly explained regarding the new hypothesis and findings. Suggestions may be added that contain recommendations on research or input that can be used directly by the reader.




Figure 1. A sample chart/figure
