IN CONFORMITY WITH THE OCTOBER 6, 2023 ENACTMENT OF CALIFORNIA SENATE BILL 411 (PORTANTINO) AND LA CITY COUNCIL APPROVAL ON NOVEMBER 1, 2023, THE DEL REY NEIGHBORHOOD COUNCIL MEETINGS WILL BE CONDUCTED VIRTUALLY.

Every person wishing to address the Board must dial (888) 475-4499, and enter 854 0137 9040 and then press # to join the meeting. When prompted by the presiding officer, to provide public input at the Neighborhood Council meeting the public will be requested to dial *9 or use the Raise Hand option, to address the Board on any agenda item before the Board takes an action on an item. Comments from the public on agenda items will be heard only when the respective item is being considered.

Comments from the public on other matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to 1_minute per speaker, unless adjusted by the presiding officer of the Board.

SB411 Updates

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or

internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.

- (C) The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time.
- (D) Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.
- (E) (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph (D), to provide public comment until that timed public comment period has elapsed.
- (ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.
- (iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.

1. Call to order and Introductions: President Ravi Sankaran called the meeting to order at 7:02 p.m. Member Hegedus called the roll and quorum was met.

<u>Members Present</u>: Sankaran, Schonwald, Hegedus, Damata, Rosenthal, Reynolds, Sanchez, Turquand, Perez, Menendez, Bhagat, Richards, Tropp.

Members Absent: Siegal, Roth.

2. Update on Board activities and announcements

- a. Update on prior motions and/or events
 - Culver-Slauson Recreation Center Holiday Party, Saturday, December 21
 Sankaran noted it was a successful event and Councilwoman Park was there to read to the kids as Mrs. Claus.
- b. Upcoming events
 - LAHSA Homeless Count, Thursday, February 20, 8pm, Culver City Presbyterian Church. Register to volunteer at https://count.lahsa.org/
 Ron Kato, lead organizer, asked people to sign up online on the LAHSA website. Kato noted volunteers will be divided into groups to cover the 15 divided areas of Del Rey.
 - ii. 2025 NC Board Election- refer to https://www.delreync.org/elections
 - Candidate Forum Tuesday, February 18, 6pm, Zoom
 20 candidates running for 15 seats on board. Vote by March 9th.
 - Ballot request deadline Monday, March 10
 - Ballot mailing deadline Tuesday, March 18
 - iii. Earth Day Tree Adoption event, Saturday, April 19 (subject to board motion)Member Sankaran noted they are giving away 150 trees to residents in LA.

3. Government Reports and Presentations

a. LAPD Pacific Division SLOs Aceves & Ramirez

Officer **Aceves** stated crime statistics from January, showing overall reduction in crime. A burglary prevention town hall meeting was held to inform individuals on home and vehicle safety, and the theft penalty was put into effect.

Member **Bhagat** noted areas of concern near Braddock Elemetary, Inglewood, Centinela, Ballona Creek, and people speeding across single resident family streets. Aceves stated they will ask traffic staff to be there along with Mindanao Way.

- b. LA City Council District 11: Councilwoman Traci Park and Matthew Halden, Field Deputy, Matthew.Halden@lacity.org
 - Park stated they resigned as 2028 Olympics chair to work with new ad hoc committee to manage, rebuild after the fires. Park noted Julio Torres, the new CD11 office liaison who will work with Matthew Halden. Park stated a joint jurisdictional meeting on Feb. 18th with CHP, CALtrans, LAPD addressed encampment issues.
 - 2. A Del Rey community town hall will be held on Feb. 24th from 6-7:30 pm on Zoom. A meeting on the Vista Motel will be held Feb. 26th at 3 p.m. CD11 is hosting a tax prep and resource fair at Mar Vista Gardens resource fair on March 1st. Park stated they are working with HACLA, DOT and LAPD on parking issues in Mar Vista Gardens.
 - 3. Member Tropp asked what steps are taken to protect undocumented immigrants. Park stated the LAPD policy is they do no work on behalf of ICE And the office is working with civil rights and legal clinics. Members Bhagat and Turquand asked about infrastructure. Park stated there is no time like the present to talk about aging, crumbling infrastructure but the price tag is roughly half a billion-dollar deficit.
- c. LAUSD Board Member Nick Melvoin: Allison Holdorff Polhill, Senior Advisor and District Director

Polhill stated they relocated Pali elementary, Brentwood schools, Pali high school due to the fires. Polhill stated 60-70% of the campus is intact and they will reopen Jan. 2026. LAUSD Ed. Foundation has a collection fund for the school and an Amazon wishlist for rebuilding efforts.

Member **Tropp** asked about DEI in sports, what the Department of Education and LAUSD are doing to protect students and identities. **Polhill** stated they have 100% protections, names safe at any school site, student led protests, students and families educated, active and pro bona law firms working with families on all levels in preparation.

d. LA Mayor's Office: Marian Ensley, West Area Representative, Marian.Ensley@lacity.org

Ensley noted while focus has been on the Palisades fire and recovery, they haven't lost sight of
Del Rey concerns. Ensley stated a Jan. 5th meeting focused on water toxins in Ballona Creek
and concerns on pipelines. There will be a multi-jurisdictional meeting on encampment concerns
along the 90 Freeway and Inglewood and city-wide cleanups will pick back up again.

Ensley noted Tax Day and gave information on immigrations rights concerning ICE. Member **Turquand** noted the Prop 36 sanctuary clause and concern from constituents.

Turner stated the Congressman is enraged on illegal things going on in Washington D.C. with 35 pieces of litigation going on. Turner noted the two pieces of legislation introduced include the Public Taxpayer Safety Act, which delineates who can and cannot access public tax information, and the other is a bill on immigration.

 Department of Neighborhood Empowerment (DONE): Prabhjot Chamber, prabhjot.chamber@lacity.org

Chamber shared information from the city clerk: allowing NC's to contribute funding to fire relief efforts and categorize expenditures as outreach. There is a new website for neighborhood empowerment at lacity.gov which can be used for election outreach.

Chamber noted the board needs to renew their annual zoom license for \$200 and there will be an advocacy virtual workshop for budgeting on Thursday, March 6th from 6-7:30 pm. They will overview the city budget, programs, NC's and communities can participate.

- j. LA Fire Department (LAFD): Captain Lance McCloskey
- k. Park Advisory Board: Brent Goshen and Jacqueline Lauderdale
- **4. Public comment on Non-Agenda items –** Members of the public will have 2 minutes to speak on any non-agenda subject.

Elizabeth stated oversight is needed for the east side of Area E, Vista Motel and Venice 405 overpass, unhoused individuals.

Ed Sullivan stated carcinogenic chemicals are flooding the Ballona Creek, Centinela storm drain, and they would like a motion to speak on the issue in the future.

A long time **Del Rey resident** stated after coming back from two deployments, a lot has changed as minorities, families are losing housing, a long-term issue.

Edwina Magana, an Area A homeowner asked the education council about land rezoning.

Carol Taubman, a Mandeville Canyon resident, stated the monthly Vista Motel meeting with the city has changed to a CD11 safety meeting. Taubman stated they raised the point at Dec. meeting that the lease with the city is invalid, unprotected from insurance, liability standpoint and need help with issue since there is no action.

- **5.** Consent Calendar- Items that are routine in nature and do not require debate; any item may be pulled from the consent calendar for debate at the request of any Board Member
 - a. Approval of Minutes from December 5th, 2024 General Board Meeting.
 Member Sankaran set a motion to approve the Consent Calendar, seconded by member Schonwald.

Motion approved with 12 yeses from members Sankaran, Schonwald, Perez, Menendez, Hegedus, Bhagat, Damata, Rosenthal, Reynolds, Richards, Tropp, Sanchez and Turquand.

b. Motion (Daniel Perez): The DRNC approves the December 2024 and January 2025 Monthly Expenditure Reports (MER). Seconded by member Schonwald.

Member **Perez** joined the meeting late. **Perez** stated in response to emergency from wildfires, they are authorized to spend \$1,000 without approval as an effort to support wildfire relief.

Motion approved with 13 yeses from members Sankaran, Schonwald, Perez, Menendez, Hegedus, Bhagat, Damata, Rosenthal, Reynolds, Richards, Tropp, Sanchez and Turquand.

- c. **Motion (Green Committee)**: The DRNC supports CF 24-1222 to instruct LADOT to report back on guidelines for establishing priority signal timing for at-grade rail lines and Bus Rapid Transit (BRT) lines. (backup materials in meeting folder)
- d. **Motion (Education Committee)**: The DRNC supports a \$514 NPG for Friends of Short Avenue Elementary to establish an outdoor classroom space.
- e. **Motion (Education Committee)**: The DRNC supports a \$500 NPG for the Pathfinder Network to provide supplies for the POPS program which supports youth impacted by incarceration, deportation, and detention.
- f. **Motion (Education Committee)**: The DRNC supports a \$300 NPG for Marina del Rey Middle School to provide food for its annual Telescope Night on March 6th.

6. New Business:

- a. Motion (Daniel Perez): The DRNC approves the following emergency expenditures made with the approval of the DRNC President in response to the Mayor's Local Declaration of Emergency related to the Palisades wildfire:
 - i. \$287.62 at Target for toiletry supplies distributed by PATH to evacuees
 - ii. \$350 to World Central Kitchen
 - iii. \$360 to LAFD Foundation

b. **Motion (Ravi Sankaran)**: The DRNC agrees to hold an Earth Day Tree Adoption event on Saturday, April 19th, at Marina del Rey Middle School, in partnership with Council District 11, LADWP and other City departments. **Seconded** by member **Hegedus**.

Member **Sankaran** stated they are giving out 150 trees as part of an Earth Day resource fair.

Member **Bhagat** asked if it was possible to be planted on the street sidewalks. Member **Sankaran** noted they would need a separate policy for sidewalk, not parkway trees.

Motion approved with 13 yeses from members Sankaran, Schonwald, Perez, Menendez, Hegedus, Bhagat, Damata, Rosenthal, Reynolds, Richards, Tropp, Sanchez and Turquand.

c. Motion (Education Committee): The DRNC supports a \$1,000 NPG for Short Avenue Elementary School for purchase of audio book materials. Seconded by member Schonwald.

Member **Hegedus** noted it has already been passed by the education committee.

Motion approved with 13 yeses from members Sankaran, Schonwald, Perez, Menendez, Hegedus, Bhagat, Damata, Rosenthal, Reynolds, Richards, Tropp, Sanchez and Turquand.

d. Motion (Daniel Perez): The DRNC approves up to \$750 for the purchase of DRNC-branded quarter-zip sweaters for the board members. Seconded by member Schonwald.

Member **Sankaran** noted they have reservations on spending this much money for merch and would rather buy sweaters with their own money. Members **Rosenthal** and **Bhagat** stated it needs to go to the community.

Motion does not pass (6-5) with members Sankaran, Hegedus, Reynolds, Bhagat, Turquand, Rosenthal voting no. Members Schonwald, Perez, Menendez, Richards and Sanchez voted in favor.

Members **Damata** and **Tropp** abstained from the vote.

e. **Motion (Ravi Sankaran):** The DRNC appoints Jeffrey Tropp as its Homelessness Liaison with the Department of Neighborhood Empowerment (DONE). **Seconded** by member **Hegedus**.

Member **Bhagat** noted if they are going to be representing the board and Del Rey community, they need to be speaking on behalf of what the majority thinks. Member **Sankaran** noted it is

not a policy making group, they are listening to perspectives.

Prabhjot Chamber stated it has nothing to do with policy making, they will be the bridge between NC's and broader community partners, a resource information program contributing efforts towards combatting homelessness.

Member **Reynolds** stated they can vouch for member **Tropp**, who has lived experiences and speaks on behalf of the community with a goal to get people services and inside.

Member **Turquand** noted they came on the board to defend neighborhoods from homelessness but stated they think Jeffrey would do a great job.

Motion approved with 13 yeses from members Sankaran, Schonwald, Perez, Menendez, Hegedus, Bhagat, Damata, Rosenthal, Reynolds, Richards, Tropp, Sanchez and Turquand.

f. Motion (Green Committee):

WHEREAS, the City of Los Angeles is committed to environmental sustainability and reducing waste through enhanced recycling efforts;

WHEREAS, the Culver Median, owned by LA County Metro, and other areas within the Del Rey neighborhood including Stoner Avenue between Braddock and Lindblade currently lack accessible public recycling bins adjacent to existing trash bins, leading to potential recyclables being discarded as waste;

WHEREAS, the placement of public LA Sanitation & Environment (LASAN) recycling bins, similar to those on Venice Boulevard, would provide residents and visitors with convenient opportunities to participate in recycling and contribute to the city's waste reduction goals;

THEREFORE, BE IT RESOLVED, that the Del Rey Neighborhood Council supports the installation of public recycling bins on the Culver Median and throughout the Del Rey neighborhood, strategically located next to existing public trash bins;

BE IT FURTHER RESOLVED, that the Neighborhood Council requests that LA Metro permit the placement of City recycling bins on the Culver Median in coordination with LASAN;

BE IT FURTHER RESOLVED, that the Del Rey Neighborhood Council urges the City of Los Angeles LASAN to allocate necessary resources for the installation and ongoing maintenance of these recycling bins to ensure continued community benefit and environmental impact.

Seconded by member Perez.

Member **Sankaran** noted they need to be strategic in how they lobby.

Motion approved with 12 yeses from members Sankaran, Perez, Menendez, Hegedus, Bhagat, Damata, Rosenthal, Reynolds, Richards, Tropp, Sanchez and Turquand.
