From the author: Listening to these audio recordings was most difficult. On 22 May 2018 – I was so happy. I had completed the 2-List of Events & Recordings - it was enough evidence to show the big picture via psy-emo manipulation to push their agenda at no cost. No respect for life.

February to April 2018 time period – Cruelty of the worst kind – torture without physicality. Prisoners at the mercy of psychopaths and they have people helping them – the edge, of course is illegal electronic monitoring – “Spying” led them to premeditate next course of actions. Illegal electronic monitoring was also active at Theresa Lavergne’s household – including other family members. Guertin and Trepanier illegally surveyed key family households at the drop of a hat. Then instigated disinformation to divide the family. I used to spend time with Michel & Jennifer’s children (e.g. go to fair ground, karaoke and record ourselves, laugh) – same with Nicole Periard’s two boys – nephews of Mark.
