- Statistics: are healthy across categories.
- Lou talked about January's programming, including the Teen Takeover, Tyke Tales, the community garden, and more. There was strong interest and attendance at most or all events, across a variety of topics.
- Lou broached the idea of hosting a drag story hour in June, for Pride Month, and knows someone who could do it. The board weighed the net community benefit against the potential for protests or worse from people who might oppose the idea. The board decided that for this year, we will not hold a drag story hour, but will provide other kinds of robust and varied programming for Pride Month.

#### Old business

• EV Charging station: we have received the funds, but do not have the actual station yet - details about the installation still to come, possibly when the ground is not frozen.

- 2025 Seneca County Ask: the library's ask to Seneca County increased this year by 10%, from \$25,000 to \$27,500.
- SSCS Tax Levy Ask: Ovid intends to increase their ask by 3.66% to \$89,000.

Motion to increase the library's ask on the SSCS school ballot by 2.5% to \$88,000 or the amount that Interlaken will ask (not to exceed 5%), whichever is greater: Karen

 Risk Management Resources: the board reviewed risk management exercises in light of the current changes at the federal level. The board needs to continue to be vigilant and forward-looking in creating robust risk management responses for the library, a challenging task given the volatile climate.
