## **12. NEW BUSINESS**

- a. Vote on the cost for Charles to provide entertainment at the Come Together Weekend (\$1,000)
- b. MOTION: Board approves spending up to \$1,000 to bring Charles Katz in for the Coming Together Weekend entertainment. (KB/MB) PASSED**
- c. No official budget for the Coming Together Weekend - fees will depend upon number of attendees (~25 at workshop and ~40 at Banquet and ~12 for Board Box Lunch); costs may vary depending on head count, \$\$\$ of Sponsorships, other fundraising that will off-set costs.
- d. **MOTION: The PDC Committee has permission to spend up to \$6,000 in excess of what we collect through Sponsorships for this conference. (KB/ED) MOTION WITHDRAWN**

**RATIONALE:** Members have had no benefits for the past two years, and this would be a way to give back to the Membership for their faith and consistency in paying membership dues.
