VERBATIM RECOMMENDATIONS:

From ABC Board Staff:

After review and discussion, our first recommendation is Charles Triber for the following reasons:

- 1. 20+ years of experience in the food/beverage industry to include being a mixed beverage permittee. He was a customer of the ABC system and will be able to bring a 180-degree perspective to the Board.
- 2. Mr. Triber reached out twice to get additional information about the Board, its mission and responsibilities, and how he can add to its effectiveness.
- 3. He sat in on our Board meeting in March and took a tour of the warehouse. After the meeting, he met with Board members and staff.
- 4. Staff's first impression of him is that he is positive, articulate and genuinely interested in positive contributions to the Board.

From Audit Committee Staff:

For the CPA vacancy, I would recommend Nate Hathaway. He has a decade of audit experience, should have good knowledge of internal controls, and has worked with audit committees in various functions. I think he would be a great addition to the Audit Committee.

Sandra Frempong would be a good candidate for the at-large seat. Though she didn't provide her resume, she does have an in-active CPA license and should be able to interpret audit reports and possess an understanding of internal controls. Since she has served on another committee she has familiarity with local government and should understand how the board/committees operate. She should be able to contribute positively to the Committee.

From NAC Chair:

I feel that this is a welcoming addition to the committee. I do feel that this person is far more qualified for this committee. Her experience, education, and focus on marketing could possibly give us more of a broader picture of moving forward with information with community. Let's move forward with her appointment.
