Course Description

This course is the first formal exposure that students have to the world of microeconomics: the branch of economics that studies the behavior of individuals (people, households, and firms). Topics include scarcity and the economic way of thinking, markets and price determination, elasticity, measuring the value of markets and market interventions, industry structure and outcomes, profit maximization by firms, an introduction to game theory and strategic behavior, and an introduction to international trade.

This is a 4-week, online, asynchronous course. There are no face-to-face class meetings scheduled and all course content, homework, and exams will be administered online in Brightspace. Students will take exams remotely in Brightspace with Respondus LockDown Browser with Monitor. There is no additional fee for Respondus LockDown Browser with Monitor.

- Note: this is not just a textbook, but an online learning platform that includes homework, podcasts, and your text. Purchasing just the textbook from an outside source will not let you access homework.
- I recommend purchasing the digital version directly from Achieve when you access it through the Brightspace page. This is your cheapest option.
- If you purchase the “book” from the bookstore, you will get an access card which is basically like a gift card to pay for the digital version of the book.
- You do not need to purchase the textbook immediately. There is a 10 day grace period once you register through Brightspace. I recommend doing this. If you are not sure if what you are getting is correct, ask (anonymously) in the discussion board in Brightspace “Questions about the Class”

Your grade in ECON 251 will be determined by your performance on Quick Quizzes, podcast assignments, homework assignments (aka, “End of Chapter Assignments” or EOC for short), 4 exams, and 4 discussion contributions.

Exams: There are 4 exams. The first three exams will each have 25 questions (100 points per exam) and you will have 1 hour (60 minutes) to take each exam. The Final Exam is Exam 4, and it is cumulative. The Final Exam will have 40 questions and be 2 hours long. Exams are a mix of question types, including multiple choice, essay/free response/matching, etc.

In general, the exam window opens every Friday at noon (with the exception of the final exam which opens at 9:00 AM) and closes at 10:00 PM on Sunday. The final exam opens at 8:00 AM on the last day of class (August 2) and is due before 11:59 PM on Sunday, August 4.

Exam 1 will cover modules 1-3,
Exam 2 will cover modules 4-7,
Exam 3 will cover modules 8-10,
Exam 4 is a comprehensive final exam.

You will need a computer with a working webcam to take exams using Respondus Monitor with Lockdown Browser. More information about Respondus will be available on Brightspace in the Start Here folder in Content.

Podcasts: Most modules have a podcast associated with them. The best way to use these is to do them before starting the module as they give you some idea of what the module is about. Each podcast has a few questions associated with the podcast. Note that the grace period applies to these as well.

Quick Quizzes (QQ): These are small mini-quizzes to give yourself a moment to pause and really check that you are understanding the material. There are 27 of these planned, and the lowest 2 scores are dropped. You often have multiple attempts at each of these.

End of Chapter Problems (EOC): These are formative assessments designed to give you practice applying concepts and building your skills. You can work on these a few at a time, log off, and then return to those you haven’t answered yet at a later time as long as you complete it by the due date. Any question not completed by the due date is graded as incorrect. You get instant feedback on each question you answer and can reattempt any question up to the due date. Each question attempt has a 1% penalty on subsequent

attempts on that question. If you are stuck on an EOC question and need help, feel free to post the question on the class discussion forums and ask for help. Note that homework questions are not all indicative of the types of questions, and difficulty of questions, that you get on exams. They are meant to *build* understanding, not test your understanding.

Group Discussion: You are required to submit at least one discussion contribution each week, usually a response to a prompt. Each discussion contribution is worth 10 points each. Discussions are due Sunday at 11:59 PM with the exception of the week 4 discussion which is due Friday of week 4 at 11:59 PM.

Your grade is based on the percent of points earned in the course:

Participation and Assignment policies

Late work on items on Achieve is accepted up to 3 days late with no penalty. After 3 days late work is not accepted.
