Privacy Policy

Kahaniya has launched the नैतिक कहानियां (Naitik Kahaniya) mobile application that can be downloaded free of cost.

This page is used to inform visitors regarding our policies regarding the collection, use, and disclosure of Personal Information if anyone decided to use our mobile app and services inside.

If you choose to use our App and Services, then you agree to the collection and use of information in relation to this policy. The Personal Information that we collect is used for providing and improving the Services. We will not use or share your information with anyone except as described in this Privacy Policy.

Information Collection and Use

For a better experience, while using our App and Services, we may require you to provide us with certain personally identifiable information, including

- 1. You need to log in with your mobile number for unique identification and post the stories in the app only. There is no need to log in to read the stories within the app.
- 2. You need to enter your full name, city, address, and profile picture which will be used to maintain the profile.

The information that we request will be retained by us and used as described in this privacy policy.

The app does use third-party services that may collect information used to identify you.

Log Data

We want to inform you that whenever you use our App or Services, in case of an error in the app we collect data and information (through third-party products) on your phone called Log Data. This Log Data may include information such as your device Internet Protocol ("IP") address, device name, operating system version, the configuration of the app when utilizing our Service, the time and date of your use of the Service, and other statistics.

Cookies

Cookies are files with a small amount of data that are commonly used as anonymous unique identifiers. These are sent to your browser from the websites that you visit and are stored on your device's internal memory.

This Service does not use these "cookies" explicitly. However, the app may use third-party code and libraries that use "cookies" to collect information and improve their services. You have the option to either accept or refuse these cookies and know when a cookie is being sent to your device. You're not allowed to attempt to extract the source code of the app, and you also shouldn't try to translate the app into other languages or make derivative versions.
