Money Cube Privacy Policy

1. Privacy Policy

The privacy of the user is important to us. We may use your personal information to send important notices, track events, rewards coins, or send any personal information about purchased or downloaded communications such as emails, device IDs, or any other means of electronic identification when using the app Changes in our terms, conditions and policies. The data we collect may include but is not limited to: email address, country; if you provide us your email address, we will not share your email address with any third party. This Privacy Policy Manages the Collection, Use, Maintenance, and Disclosure of Information Collected by Users (Each "User") of the Money Cube Application ("App").

2. Personal identification information

We may collect personal information such as email, device ID, country or any other electronic means of identification when using the app. We do not display your private personal in our app without authorization, like phone number, contact, location.

3. Non-personal identification information

We may collect non-personally identifiable information about users as long as they are associated with our application. Non-personally identifiable information may include the type of computer and technical information about users connecting to our applications, such as operating systems, installed apps and other similar information.

- 4. How we use the information we collect
- Money Cube collects and uses personally identifiable and non-personal information for the following purposes:
- We may use your personal information to send important notices, track events, award coins or send communications about purchases or downloads, and change our terms, conditions and policies.

We employ appropriate data collection, storage, and processing practices and safety measures to prevent unauthorized access to, alteration, disclosure or destruction of the information and data stored in our applications.

Sensitive and private data exchange between an application and its users takes place over SSL secure communication channels and is digitally signed for encryption and protection.

6. Share your information

We do not sell, trade or rent user information to others. To do this, we may share general demographic information with our business partners, trusted affiliates and advertisers that are not related to any personally identifiable information about visitors and users. If you provide us your email address, we will not share your email address with any third parties with you.

To improve our product and provide you with better service, we also share personal data with vendors or agents working on our behalf for the purposes described in this privacy policy. For example, companies we've hired to provide data analytical services may need to collect and access personal data to provide those functions. In such cases, these companies must abide by our data privacy and security requirements.

7. Collection of information

The data we collect depends on the context of your interactions with us, the choices you make, including your privacy settings, and the products and features you use. The data we

collect can include SDK/API/JS code version, browser, Internet service provider, IP address, platform, timestamp, application identifier, application version, application distribution channel, independent deice identifier, iOS ad identifier (IDFA), Android ad master identifier, network card (MAC) address, and international mobile device identification code (IMEI) The equipment model, the terminal manufacturer, the terminal device operating system version, the session start / stop time, the location of the language, the time zone and the network state (WiFi and so on), the hard disk, the CPU, and the battery use, etc.

8. Legal basis for data processing

We process Personal Data for the purposes set out in this Privacy Policy, as described above. Our legal basis to process personal data includes processing that is: necessary for the performance of the contract with you (for example, to provide you with the services you request and to identify and authenticate you so you may use the Sites); necessary to comply with legal requirements (for example, to comply with applicable accounting rules and to make mandatory disclosures to law enforcement); necessary for our legitimate interests (for example, to manage our relationship with you, to ensure the security of our services, to communicate with you about our products and services); and based on consent by our customers (for example, to place certain cookies and to share your information with third parties for advertising purposes).

9. International Transfers of Personal Data

Our business may require us to transfer your Personal Data to countries outside of the European Economic Area ("EEA"), including to countries such as the People's Republic of China or Singapore. We take appropriate steps to ensure that recipients of your Personal Data are bound to duties of confidentiality and we implement measures such as standard contractual clauses. A copy of those clauses can be obtained by contacting our Help Center.

10. Your Rights

Subject to limitations in applicable law, you are entitled to object to or request the restriction of processing of your Personal Data, and to request access to, rectification, erasure, and portability of your own Personal Data.

If you are aware of changes or inaccuracies in your information, you should inform us of such changes so that our records may be updated or corrected. You may lodge a complaint with a supervisory authority if you consider that our processing of your Personal Data infringes the applicable law.

We retain your Personal Data as long as needed to provide services or products to you, or as required or permitted by applicable laws, such as tax and accounting laws.
