The Honorable Resignation Act is an act created for those who have earned the right to an honorable dismissal from Paragon. This act applies to members of Paragon who have dedicated their time, effort, and skill to the Foundation. Members are selected by the O5 Council, and must have met some basic requirements.

We, the O5 Council, are appreciative of the many members here at Paragon, who have dedicated their time, memories, efforts, skills, and whatever else any individual has offered to help this Foundation Prosper and grow. And so, because of this, we have come to an agreement that one must be given a proper farewell, and thank you for their outstanding work.

## SECTION 2 – REQUIREMENTS

There are specific requirements that must be met for Security Class - 3 and Security Class - 4 alongside Councilors of the Foundation. If a member meets the requirements set by the Council, they are eligible for an honorable resignation.

**For Security Class - 3 and Security Class - 4 Personnel, the following requirements must be met:**

- ❖ Must have been a member of Paragon for an adequate amount of time
- ❖ Must have a good standing with the majority of Command Members, and O5 Council
- ❖ Must have accomplished multiple feats within the Foundation
- ❖ Must have had a considerable impact within their original department
- ❖ Must be selected by the O5 Council upon resignation

**For O5 Councilors, the following requirements must be met:**

- ❖ The Chairman shall be notified with a minimum of 1 week of advance notice
- ❖ Retiring Councilor shall be on good terms with the Council and the Foundation
- ❖ Perks can be withdrawn should a former Councilor discredit or damage the reputation of the Council or the Foundation post-resignation
- ❖ Served as a Councilor for 1 month

## SECTION 3 – REWARDS

Upon a member's resignation they will be rewarded for their efforts and time within Paragon Research Institute. Based on retirement Security Class and/or rank, members may be given different benefits.

### **Retirement at Security Class - 3:**

- ❖ 100 days of Supporter
- ❖ Choice of 1 gamepass
- ❖ Honorary SC-1 permanently, unless burned, fired or otherwise
- ❖ Honorary Role in Department → Discord Role
- ❖ 10,000 in game credits

### **Retirement at Security Class - 4:**

- ❖ 365 days of Supporter
- ❖ Choice of 2 gamepasses
- ❖ Honorary SC-2 permanently, unless burned, fired or otherwise
- ❖ Honorary Role in Department → Discord Role
- ❖ Ability to join any department at highest NON-COMMAND position with approval from incumbent overseer (Excluding AAC, AA, LorD, and MaD)
- ❖ 25,000 in game credits

### **Retirement at O5 Councilor:**

- ❖ Ability to remain at a non-command rank in 2 departments of their liking so long as the incumbent Overseer agrees
- ❖ Permanent supporter perks
- ❖ 'Former Councilor' role in the main Discord server
- ❖ Permanent Security Class 2 (if desired)
- ❖ Delta-1 protection at SC4 priority for 3 months following resignation
- ❖ Permanent on-site portrait
- ❖ Honorary role in any department the councilor served
- ❖ Any other perks which may be requested by the resigning councilor, require approval from the Chairman
- ❖ Under special circumstances the Chairman of the Council may resign an O5 designation following the O5's resignation

*The O5 Council reserves the right to remove an individual's benefits at any given time, should it be necessary.*
