Role: Technical Expert- Supply Chain

Location of Assignment: East and Southern Africa (Remote) with occasional travel

Duration: 5 months

Part 1: Introduction

Family Planning 2030 (FP2030) is a global partnership of governments, civil society, multilateral organizations, donors, the private sector, and researchers committed to supporting the rights of women and girls who wish to use contraception. Our vision is a future where women and girls everywhere have the freedom and ability to lead healthy lives, make their own informed decisions about using contraception and having children, and participate as equals in society and its development. Since our founding in 2012, much has been achieved, but more remains to be done. The global family planning community agreed that the gains of the last nine years should be sustained by extending this pivotal partnership. Through a global consultation, stakeholders from around the world provided their input on the future of family planning. Together, the community created a shared vision for 2030 that builds on progress achieved to date, adapts the partnership in response to the lessons of the first nine years and positions us to achieve the future women and girls around the world are asking for.

The FP2030 East and South Africa (ESA) Hub is committed to advancing the family planning agenda in this region which covers twenty-three countries. Recognizing the potential that the hub must elevate the place of family planning not just as a health issue but as an economic issue and an important part of development, the ESA Hub is focused on establishing visibility in the region during this first full year of operations and in the second year, the hub strengthened its engagement with countries. In this third year and keeping in mind of the evolving dynamics in global development, the hub intends to deepen, expand, and accelerate its impact. In view of this, FP2030 is seeking part time Technical Experts to work with its portfolio technical teams and

through this engagement, it is expected that FP2030 will provide technical assistance which will contribute to strengthening the health systems and achieve deeper impact in countries.

Part 2: Purpose of the Assignment

The primary objective of this consultancy is to provide technical support and strategic guidance to the Ministry of Health and country partners in managing and strengthening their supply chain systems for family planning commodities.

Part 3: Scope of Work

- Assess current supply chain challenges and gaps in selected FP2030 commitment-making countries.
- Asses the status of Visibility Analytics Network VAN in relation to efficiency and effectiveness and provide necessary recommendations to the Ministry of Health
- Assess the effectiveness and efficiency of the current supply chain system and provide necessary recommendations.
- Training MoH officers in utilization of Supply Chain system, tools, and procedures including Forecasting and Supply Planning (FASP) and Visibility Analytics Network (VAN)
- Support the adoption of innovative and technology-driven solutions to improve forecasting, procurement, and distribution of commodities.
- Provide technical assistance and capacity-building support to Ministry of Health supply chain officers to enhance supply chain efficiency and resilience.
- Develop and implement strategies to mitigate disruptions and ensure uninterrupted supply of contraceptives and reproductive health commodities.
- Facilitate coordination between governments, donors, and implementing partners to align supply chain strategies.

Part 4: Payment Schedule

The technical expert/ consultant is to be engaged for five months and payable upon satisfactory execution of the milestones in the contract. The monthly payment is pegged to delivering outputs in the different phases.

- Strong written and oral communication skills, including the ability to produce clear and concise reports, narrative documents, and presentation materials.
- Strong analytical, problem-solving, and strategic thinking skills.
- Ability to work independently and adapt to dynamic, multi-country contexts.
