- III. Upcoming reminders (Heather will send emails):
 - a. Let Heather and Vicky know about Fall honors course offerings in your department
 - b. Medals for departmental honors graduates Heather will send out an email request next month
 - c. Be sure to inform the registrar of any graduates 5-6 weeks prior to graduation (this is so it will be printed on their name card)

IV. Discussion:

- 1. Students should only enroll in 3 credits **total** of thesis work. This can be spread over 2 semesters. Reasons:
 - a. 3 credits signals to the Registrar that the thesis is complete
 - b. A 6-credit thesis is a Master's thesis; we want to maintain equity in our expectations of undergraduates
 - c. If students wish to work over 2 semesters but enroll in all 3 thesis credits their final semester, they could enroll in 1-3 credits of an independent study, research assistantship, etc.
 - d. Financial aid will not cover the additional 3 credits of thesis: this is significant for students on Federal aid

- 2. The challenges of doing dual departmental honors:
 - a. Requirements vary widely across campus ie, a Spanish thesis requires writing in Spanish.
 - b. Trickiness of developing a project that fully speaks to both disciplines (can be easier in some disciplines than others)
 - c. Requires a 6-credit thesis, which can be difficult for undergraduates to complete
 - d. Students also need to complete honors coursework in both disciplines (which mostly means 4 honors courses) = students may come to departmental honors later in their time at Appalachian
 - e. Where the thesis 'counts' (such as capstone, a major elective, etc.) varies widely across campus
 - f. If the student does wish to pursue, the co-directors should be in touch early and often to coordinate
 - g. Honors College staff are here to support faculty and answer questions.
