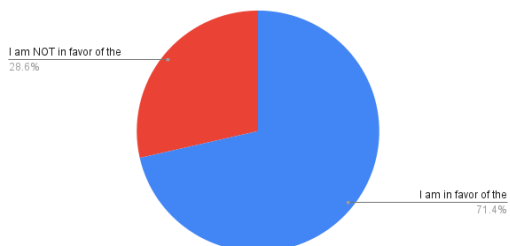
Salaried Financial Plan Update
