## **Executive Director Report**

Executive Director: Colby Heckendorn

Staff is coming off intercession, and they had a full week of strategic planning, reflection, data, meetings on student support, grade level team meetings on curriculum.

- Report on October Highlights: place-based learning at work!
  - Expeditions to Forest Park, Circus Flora, and MADE, fourth expedition is planned. They are purposeful and meaningful, and connected to the curriculum. Families have been really receptive to this part of the Atlas Model.
  - Small adjustments have been made to the daily schedule to improve the structure of the day and adjust to the space.
  - Leadership is working to fully leverage the two teachers in classroom model to improve student experience and outcomes.
  - Before & After School Programming has been run in-house thus far. This week, Atlas received the 21st Century Grant, a grant that was co-written with Unleashing Potential, who will manage before and after care at an extremely discounted rate for our families. An Atlas team member will remain with Unleashing Potential to support students academically and socially during the before and after school time.
