

Stormline's Terms of Service

By purchasing a commission, design, or product from me, you are agreeing to my T.O.S. and that you will abide by all conditions listed below.

Note: any time "I" is written in this document, I'm referring to myself (Stormline).

Section A: General T.O.S.

- 1. If you are blacklisted by me, you are not allowed to buy, trade for, sell, or own any of my designs or art. If you owned a design or art piece by me before you were blacklisted, you may keep it, however you may not purchase any further designs made by me.
- 2. All transactions are to be performed in USD (\$).
- 3. I may block or blacklist at my discretion. If I have blocked you (mid-commission process) without telling you beforehand, you are entitled to a full refund.
- 4. I will not work with homophobes, transphobes, racists, xenophobes, sexists, etc.

- 5. My T.O.S. is subject to change as I see fit. You are bound to this T.O.S. from the moment you commission me. I will automatically assume that you have read this document if you commission me.
- 6. I will not work (with real money involved) with anyone under 13.
- 7. Using my work for NFTs, AI, or any other nefarious purposes will result in blacklisting.
- 8. Do not attempt to argue pricing if I have the price listed explicitly in my commission sheet.
- 9. Tracing, copying, or directly and heavily referencing my work will result in blacklisting.
- 10. You may ask about any user listed on my blacklist, but I do not owe you an in-depth explanation.
- 11. Lying about your age to purchase an NSFW commission from me will result in an immediate blacklist, block, refund, and report to the social media we discussed through (and in severe cases, the authorities).
- 12. I will NEVER accept commissions with themes of zoophilia, pedophilia, or anything close to these topics. I will *never* draw animal genitalia for my NSFW commissions.
- 13. Chargebacks without prior negotiation will result in you being blacklisted from future commissions permanently.
 - a. If the product was physical, and the commission was completed, I reserve the right to resell the commission if a chargeback was filed.
- 14. I take payments in forms in order of priority (highest at the top, lowest at the bottom):
 - a. Venmo
 - b. Cashapp
 - c. PayPal
 - d. Cash (in-person transactions only)

Section B: Commissions and Products

- 1. I reserve the right to refuse or cancel a commission for any reason. I do not need to explain to a client why.
- 2. I will not accept commissions containing racist, homophobic, xenophobic, etc. themes or ideals.
- 3. Full payment must be sent after a WIP has been approved by the client.
- 4. Should I cancel a commission myself, a full refund will be issued.
- 5. Should a client cancel their commission, refunds will be issued according to the criteria listed below:
 - a. Sketch stage: Full refund.
 - b. Coloring stage/sewing stage has begun (or 50% completion, whichever comes first): 50% refund.
 - c. Commission has been completed: No refund.
- 6. Commissions will take no longer than the deadlines listed below (sorted by type), unless otherwise explicitly specified:
 - a. Digital pieces (ex. designs, artwork): 6 months
 - b. Animation: 1 year, depending on length and complexity of animation
 - c. Wearable accessories (ex. ears, tails, collars): 6 months
 - d. Fursuits: 1 year
 - e. Physical goods (ex. keychains, pins, stickers): 3 months after being delivered to me from manufacturer
 - f. Traditional art (ex. paintings, physical drawings): 5 months
 - g. Plushies: 1 year
- 7. Commissions not completed within the timeframe given will be refunded to the client as soon as possible.
 - a. Note: Most, if not all, commissions will be completed well before the given timeframe.

- 8. I am not responsible for any physical items being lost or stolen once I have sent you evidence of the item's delivery to the post office and your tracking number has been sent to you.
- 9. Clients must pay the shipping cost for any physical items.
- 10. Physical items may not be a 100% accurate color match to any references provided. Some slight variation is to be expected, however I will do my best to color match.
- 11. Commissions are not for commercial use unless I have approved so. We will discuss pricing of commercial use rights beforehand.
- 12. Do not claim my art as your own, regardless of if you paid for it. Do not remove my watermark.
- 13. I reserve the right to use your commission as an art example for the advertisement and promotion for my brand. This may include the commission being posted on social media.
- 14. Do not alter your commission yourself; if you need something to be changed, let me know.

Section C: Designs

- 1. I will not copy or plagiarize pre-existing designs for you when making customs.
- 2. Once the design is completed, it belongs to you. However, use of my design in hateful conduct will result in you being blacklisted.
- 3. My designs may not be sold for more than you bought them for unless you have added additional art to them. Gifts, raffle prizes, etc. start at a worth of \$0.
- 4. I must be able to access my designs at any time.
- 5. Unless we have discussed and I have agreed otherwise, all designs made by me must stay on Toyhou.se (https://toyhou.se/) or anywhere else I have quick and easy

- access to my designs. If you need a code for Toyhou.se, you may reach out to me, and I will try to help you get one.
- 6. You may not detransition, whitewash, or age up my designs for the purposes of NSFW. Please do not turn any of my fat designs skinny.
- 7. You may redesign my designs as you see fit as long as you own them, but the original design must be credited to me at all times.
- 8. Do not buy a design just to resell. You must wait 5 days before reselling my designs.
- 9. You may not resell designs you do not have permission to use.
