Entrance / Exits Social Distancing of parents / children during pick up / drop off. Can separate entrances and exits be allocated? If school based, can club have their own entrance/exit to other parents?							
Signing in / out Cross contamination of pens, can a member of staff be allocated to sign in / out?							
Taking Cash payments Contamination. Can BAC's / contactless / ParentPay payments be used?

Staggered drop offs/Collections/transportation Social distancing of parents / children. Children over 11 years to wear face coverings whilst in transportation. If using a vehicle, can you have consistent groups of children accessing the same vehicle? Are you implementing additional vehicle cleaning?							
Social Distancing Do you need to allocate new rooms or can outside space be included? Consider ways to minimise mixing, ensuring staffing is as consistent as possible and agency staff taken on on a weekly rather than daily basis. Can staff socially distance during break times and during post session clean up or can breaks be staggered?							
Staffing / Volunteers Meeting staff ratios. Specific risk assessments to be undertaken with staff who may be at increased risk (e.g. those who have chosen not to receive vaccinations/unable to be vaccinated; staff with specific

vulnerabilities) and agree any additional measures required to minimise risk (e.g. use of PPE/face masks/social distancing)							
Personal Protective Equipment Contamination/ spread of germs. What will you require for staff members? How will you dispose once used? Have staff been trained in how to safely use PPE and do they know when use is required? Use of Hierarchy of Controls approach as outlined in Guidance for childcare and playwork: Coronavirus .							
Staff Uniforms Contaminated uniforms. Do the staff members have enough uniforms to be able to wash daily (can other clothing be worn)?							
Shared Staff items Contamination. Think about club mobile phones, walkie talkies, door monitor, laptops, pens etc							
Shared staff areas / rooms Contamination/ spread of germs

Consider staggered lunch breaks, cleaning of communal areas, toilets, kitchen etc.							
Cleaning Contamination. Think about a cleaning rota, staff allocated to cleaning, do you have sufficient cleaning products? PPE for cleaning safely?							
Legionella Think about the water system, has it been safely flushed? Outdoor toys, water trays, etc. See CWLWM guidance for more information.							
Central Heating Check your central heating, hot water supply, smoke alarm, fire alarms, fire extinguishers. Are all your safety certificates up to date?							
The Building Check outside for build-up of debris, weeds, vandalism etc. Is it a shared building with shared access? Do you need to mark the floor? Consider using a one-way system in high-traffic areas. Can the building be ventilated? Can the windows remain open?

Cleaning equipment Contamination. Think about a rota for cleaning toys etc, introduce an isolation box for items? Protective equipment for cleaning? Where will you clean items?							
Activities including the use of Sand / Water / Books Using the Infection Prevention and Control for Childcare Settings Guidance , are there any considerations required to minimise risk of transmission when using resources/equipment? Are there resources/equipment that will require more frequent cleaning? Do you need to set a cap for how many children are using certain resources at any time? Can more activities be taken outdoors?							
Children Lunch boxes Contamination Can they be stored safely? Do you have space for children to eat lunch safely?							
Test Trace Protect Have you implemented a policy to outline any actions/responsibilities in light of Test Trace Protect? How

will you ensure the Contact Trace Team can contact all relevant parties? Could you implement a document recording all staff vaccinations and dates? Vaccinations, whilst strongly encouraged, cannot be made compulsory for staff and unvaccinated staff must not be discriminated against, but to allow you to manage risk and introduce additional mitigating actions, it might be useful for you to know who has received both vaccinations and who has not.							
Attending more than one setting- Staff/Children Up to date documentation of when the child attends? Can you liaise with the parent to have records of when the child is in each setting? Can staff change clothes? Are there lots of opportunities to wash their hands- especially at the start of shift.							
Visitors Decide who you deem essential, does this match the guidance?
