



Artist Participation Agreement
“K-POP Idol Tour- Music -Stan Lee Legion Video Game”

Artist grants to Lunar Records/Drew Right Music, AdventFx/Paralight Pictures (producers of “Stan Lee Legion Video Game and movie) and the Sponsor **LUNARBIT**, as well as assigns their name, likeness, recording to be used in all media worldwide forever related to their participation in.

1. Stan Lee's Legion, who is creator of ‘Avengers”, Marvel, Ironman, and Spiderman, presents “Legion” a Video game by Paralight Pictures abd AdventFx, which Lunar Records will be licensing music songs, music and promotional videos and voice over recordings of

the artist and releasing in all media worldwide. Releases approximately December, 2025

2. K-POP Idol Tour in the USA. 2026. Co-produced by South Korean K-POP Idol label nCH Entertainment

Publicity/Red Carpet Events: Artist agrees to attend:

- A. Kick off red carpet events in Los Angeles
- B. K-POP Tour; USA Lunar Records has partnered with K-POP label nCH.
- C. Social Media Artist agrees to min 3 phases of promotion about their participating in the project including and will tag @lunar.records sponsor, @lunarbits222, KPOP Label @nchlabel and the social media for "Legion". Plus approved text/messaging in social media and url backlinks to the sponsor Lunarbits. Social media posts will include :
- D. Announcing they have been signed to the project.; Within 48 hours of signing this talent deal (but shall not announce any potential involvement with the movie or TV series as that is not being cast at this time).
- E. Promotion of the songs and music video that the talent records.
- F. .Promotion of the video game when it's ready for release.

The artist agrees by electronically signing and confirming herein, to the terms herein.

Fees and Compensation:

Travel expenses: Are to be paid for by the sponsor (Lunarbits) for the artist (and not their entourage/family/managers) when traveling (4 star, business) is requested outside of Los Angeles.

Date Rate: Paid by the sponsor for talent voice over recordings for the video game, 50% of SAG equivalent day rate . There is no day rate applied

for rehearsals, press and red carpet events and music recordings and social media content creation

For Touring, AEA equivalent day rate (except for any rehearsal, live performances at promotional media and red carpet and publicity event) if the artist is selected for Touring

This project is not a Signatory to SAG/AEA.

Songwriter Royalties : Should the artist participate in the writing of any songs they should be paid royalties per ASCAP/BMI at the rate of 25% composer royalties shared with Artist with Lunar Records and Drew Right Music. And if the song is licensed to blockchain/nft platforms the royalty to artist shall be 25% after deducting credit card and NFT platform fees which shall be reported transparently to the artist through such NFT platform data and royalty payout systems.

Confidential Information: Artists agree to keep the terms of this agreement confidential.

Credits: Artist shall be credited in the program, in all worldwide media; and as is customarily done in the music industry

Governing Law: This agreement shall be governed by the laws of the State of California.

Disputes: If any disputes arise between the parties then they agree to seek a remedy through mediation and if unresolved within 45 days then through binding arbitration in Los Angeles County, California, USA.
