7 Ideas to Build a Healthy Board Nomination Process

Helpful resource to share with ED's and Boards

360-degree Governance and Where are the Directors in a World in Crisis

A 55-page examination from a practical and scholarly standpoint what good governance in the 21st century should be. Produced by the Rotman School and written by Peter Dey and Susan Kaplan and with input from a huge Advisory Committee of Canadian corporate Who's Who. It's from a very corporate perspective so lots is not applicable to NFP's, however the 13 principals outlined in the 360-degree governance model would be very interesting for any Board – including not-for-profit, to adopt.

2017 Social and Demographic Trends by Jim Russell

An interesting short (3 page) discussion that explores a variety of issues and poses a number of questions for NFP Leaders such as "Despite your best efforts to master and deal with the new world of social media, how else might your business model be challenged in the era of the disappearance of context and attention spans?". Could form the basis of an interesting Board discussion session.

Imagine Canada's Standards Program for Canada's Charities and Nonprofits

This resource touches on all areas of MAS work and provides the baseline standard of practice in five areas: A. board governance B. financial accountability & transparency C. fundraising D. staff management and E. volunteer involvement. The Standards Program is first and foremost a capacity-building initiative and Imagine Canada encourage organizations to use the standards to improve and monitor their

practices. They also run a vigorous accreditation program based on the Standards but it is neither required or in fact used very much as there is no widespread expectation among funders, the public etc. that NFP's should be accredited.

CCA (Canadian Centre for Accreditation) Standards Manual for Community- Based Primary Health Care Organizations, Edition Date: May 11, 2020

Another accreditation guide, the standards outlined in this manual have been grouped especially for the Community-Based Primary Health Care organizations. The Organizational Standards in Section 2 apply to all organizations. Section 3 is sector specific, such as community-based primary care, child and youth mental health or credit counselling. Contact CCA to ensure you are using the correct manual for your sector.

Peering into the Future: Reimagining Governance in the Non-Profit Sector, BY LISA LALANDE, funded by Ignite NPS.

This paper focuses on how non-profit organizations can adapt to an increasingly complex environment by reimagining governance. It addresses how boards, leaders, staff and key stakeholders can work together to contribute to effective organizational governance from a strategic perspective. Specifically, this paper will: » Explore the current state of governance in the sector, including the legislative, regulatory and policy environment. » Identify emerging trends and challenges that impact governance at both the organizational and sector level. » Discuss promising practices and key considerations to improve the current state of governance. » Provide recommendations to improve the sector's capacity for "future-oriented governance."

Slide presentation: "Beyond Boards: Reimagining Governance, Disrupting the Status Quo" by Erin Kang - Ontario Nonprofit Network and Linda Mollenhauer - Ignite NPS

Covers: Overview of the Reimagining Governance Initiative and results of some of their consultations. The Reimagining Governance, convened by the Ontario Nonprofit Network in partnership with Ignite NPS who produced the paper (above). Reimagining Governance is an initiative designed to spark dialogue and new approaches to the way that nonprofit organizations are governed. This slide presentation provides a glimpse of some interesting alternative views on NFP governance but wouldn't likely be something MAS VCs would use with clients – at this point.

Restoring Trust in Nonprofits, ONN, 2019

23-slide presentation with some interesting statistics and information. Good to review if you're interested in the topic of trust but otherwise not likely a tool many VCs would use.

Board Recruitment and Selection - Imagine Canada blog 2018

Short discussion by Suanne Miedema, President of <u>Miedema's Board Consulting Inc.</u> where she helps nonprofit boards improve their governance.

This matrix can be adapted to assist an organization's recruitment efforts by assessing current board composition and identifying opportunities to diversify and/or expand the board.

Guide to Good Governance: Not-for-Profit and Charitable Organizations, 2013.

276-page guide produced by The Governance Centre of Excellence (GCE), an initiative of the Ontario Hospital Association. An excellent "primer" on every topic related to governance you could think of.

Ontario NFP Update on new ONCA Legislation

With a note from VC Bill Sparks describing the content here: "A very comprehensive update from Carol Jackson on ONCA and the need for our VCs to advise caution before changing Provincial NFP corporations' by-laws".

MAS Governance Framework Issues and Elements

This is an excellent little resource to get you thinking about Boards from different perspectives. It includes a very brief overview of various models of Board leadership (Carver, the Pragmatic Approach etc.) as well as "the four questions to be asked when you're serving on a Board".

Merging for Good: A Case-Based Framework for Supporting Effective Nonprofit Amalgamations

Written in 2021 after a pandemic induced merger of two NFP's in Calgary. This excellent 30 page report outlines the imperatives and challenges of nonprofit mergers and uses this case study to walk through the process.

20 Questions Directors of Not-for-Profit Organizations Should Ask about Mergers by Mark Blumberg • Andrea Cohen Barrack of CPAC (Chartered Professional Accountants of Canada)

Very thorough 56-page document: "Determining whether an organization should explore or proceed with a merger is one of the most important strategic and governance questions a board of directors can face. This document addresses the major elements directors should consider when contemplating a merger, grouped into the following areas:

- 1. Evaluating merger as a strategic option
- 2. Exploring a merger
- 3. Negotiating a merger
- 4. Implementing a merger"

Nine Lessons from a Nonprofit Advocacy Win, Posted by <u>Danielle M. Henry</u> on Boardsource, Jul 13, 2016

An informally written case study of a small local organization's experience with an advocacy project.

Board Essentials, produced by the Ontario Nonprofit Network,

This is an absolutely key document for general reference for any VC working with a Board. A quick, 7-page, summary of the key responsibilities of a Board. Could be used as a handout as well.

"Board Essentials describes the requirements and responsibilities that must be fulfilled by the board of directors, and which no other person or entity can perform. This core work of the board is based on what the law and regulations state are the requirements and responsibilities they must meet. While the board might play a significant role in fulfilling other governance functions, these are the essential ones."

Policy Statements (example) based on the Carver Board Governance Model

Produced by John Howard Society in 2014. This is a helpful tool just to give you and idea of what a Board policy document, using the Carver Policy governance model, could look like. For example, the short but easily used elsewhere Executive Limitation policy illustrates the Carver approach where the ED does everything, EXCEPT what the Board limitation policy explicitly states.

Pro's and Con's of Charitable Status

Great little (3 page) discussion piece by MAS VC Graham Boyce.

Top 10 Compliance Issues for Canadian Registered Charities. Presentation to the Sustainability Network, January 26, 2017, Mark Blumberg (mark@blumbergs.ca), Blumberg Segal LLP

Super helpful and clear 63-slide power point presentation, laying out exactly what the title indicates. A must read for all Governance VC's.

Voices of Board Chairs: A National Study on the Perspectives of Nonprofit Board Chairs, By Judy Freiwirth, Mary Hiland, Michael Burns, Gayle Gifford and Debra Beck | October 12, 2016

Very interesting discussion paper (17 pages). An American perspective although that likely doesn't change the perspective dramatically. From the authors: "As a group of practitioner researchers, we decided to find out what preparation is done by board chairs and how they see their role in relationship to the board and other stakeholders. What we found was a pretty glaring picture of neglect, in that this is an area of organizational leadership succession that is often insufficiently thought through. What follows are our findings from a survey of 635 self-identified nonprofit board chairs representing local, regional, and national organizations in forty-two states, and the recommendations to nonprofits we make in light of these findings."

Exactly as the title suggests this is an 11-step process for NFPs/fundraisers putting on a hybrid event.

Twenty Questions Non-Profit Directors Should ask about Marketing and Fundraising (prepared for MAS by Lelia MacDonald, 2015)

As noted in the Introduction: Does your Board talk more about cost containment and less about revenue generation? In a recent survey on Board performance, Board members graded themselves lowest on their role in fundraising. This e-booklet helps address this need for improvement.
