**Apparel Committee Meeting**

**Present:** Ashley Hayes (co-chair), Anna Magrini (co-chair), Paula Hargrove, Karen Apple, Anna Hargett, Alyssa Anderson

**Uniforms:** Ashley Hayes made a motion to only have the logo on Official Uniform Days on a red polo. All other days students could wear an non-embroidered red, black, white, or gray polo. Seconded by Anna Magrini.

<u>Discussion</u>: 1) It would be cheaper financially for families. 2) would help reduce confusion on official uniform days. 3) Had challenges with the vendor this year with getting orders. 4) Send a survey to parents to get feedback on the idea. 5) Possibly go to online ordering with Dean next year and continue to use Land's End. Stop using Carolina Sports. Would be good to look at options for next year. 6) Would need new apparel policy and approved vendors if approved by the board to move forward with it. 7) Kids wear hoodies most days covering up the polos.

<u>Vote:</u> Voted unanimously to approve the motion. No opposed.

**Dress Code:** Needs to be addressed and adhered to. Many violation seen. Clarification needed for parents.

**Next Year's Spiritwear Plans:** Plan to go strictly to online ordering. Will open ordering windows and then close and order by batches. A refund/exchange policy would be necessary. Will consider a no refund/exchange policy with all orders final. Will need to add a checkbox on the online ordering screen to acknowledge that you have read and understand the policy. Will need to communicate to parents early about the policy being put into place. We have had an excessive amount of returns/exchanges this year. This policy would be put into effect for the 2020-21 school year. 2-3 top selling items would be picked to keep a small inventory of for new families. Will need to clarify with Dean on the ordering process. Online ordering will make it easier for families to order when convenient for them. PTO would get paid prior to ordering.

Motion made by Paula Hargrove to add the policy that "All sales are final" to the online ordering. Seconded by Karen Apple. Committee voted unanimously that the policy would be that "All sales are final."

**Budget:** Currently showing a \$13000 inventory. Will have the biggest profit made so far by spirit wear sales if sales continue as projected. It was discussed that next year's budget needs to be itemized for apparel. It should be broken down into inventory orders and pre-paid orders.

Pre-paid orders consist of 3 seasons of athletic wear, freshmen and senior shirts, club shirts and individual sports team specialty orders. These items are pre-paid before ordered and we make a little profit off of it. The orders affect the inventory budget and push it over.

Apparel Committee Openings for Next Year: Anna and Ashley are stepping down as committee chairs. Karen and Paula are stepping down from Spiritwear. This is due to family and job obligations. Currently, Ashley and Anna handle the uniform side of things and Karen and Paula handle the spiritwear side. Word needs to be put out soon so the incoming chairs can be trained on how the committee operates, orders and chooses designs, etc. Karen and Paula would love to have someone to step in and do the last sales with us to prepare for next year and have an easy transition.

**Feb. Sale:** Need to change the date from Feb 21 to Feb 28. With the Featherhead being on the 28th, we decided to sell during the event.
