Tiny Beans Terms of Service

These terms of service apply to all activities for Tiny Beans across all platforms which Tiny Beans is active on. By participating in any of these activities or in receiving a character, you automatically accept Tiny Beans' Terms of Service. Terms of Service may be updated at any time without any notice. All users are expected to comply with Tiny Beans' Terms of Service. Violation of the Terms of Service will result in either a temporary or permanent ban, at Tiny Beans' discretion. Ownership Terms

These terms apply to all characters, regardless of the method of obtainment. Tiny Beans characters may only be created by Tiny Beans artists. Characters may not be self made. Official characters must be registered into the Tiny Beans Field Guide for ownership to transfer from the shop to the new owner.

Once a Tiny Beans character is registered in the Tiny Beans Field Guide you become the owner of the design of the pet for non-commercial purchases. You may display the art, you may commission additional art of the design, you may print the design for personal use. However, you may not use the design to create products that you profit from (monetarily or in traded goods).

Tiny Beans only recognizes the single owner listed in the Tiny Beans Field Guide for each character at a single time. Co-ownership is not permitted. Should the character be resold or traded, Tiny Beans must be alerted of this update through proper channels immediately.

Owners may trade or sell their characters to other players. Characters may only be sold for USD if they were originally purchased through USD. All transactions must be tracked in the appropriate thread. Once the transaction is completed, the party selling or trading the character fully relinquishes all rights and ownership to the recipient.

Ownership of any Tiny Beans characters may not be assigned to banned persons, listed at the bottom of this document.

Tiny Beans reserves the right to use any character or art produced for their own portfolio and promotion.

Code of Conduct

All participants in any part of Tiny Beans are expected to adhere to a basic code of conduct.

- 1. No Cheating
- 2. No hate speech, harassment, or intentionally inflammatory content.
- 3. All Tiny Beans Platforms are PG-13, no sexually explicit content.
- 4. Participants may not use multiple accounts to circumvent any rules or skew events in their favor.

USD Payment Terms

All real-life currency Tiny Beans transactions will be conducted in USD. Transactions will always occur through a PayPal invoice, never through a direct transfer or other platform. Completed payment of an invoice is an agreement to this Terms of Service and all Tiny Beans rules.

Tiny Beans reserves the right to refuse payment from any user. Chargebacks on any paid transaction will result in an automatic permanent ban from all Tiny Beans activities, and if the design was not custom it will be put back up for sale.

Payment plans will only be accepted on purchases equal to or greater than \$50. Payment plans must be discussed and approved with DarkHeartedSorrow prior to purchase or bidding. Payment plans will require a nonrefundable 25% down payment. The remaining balance must be paid within 30 days of purchase. Defaulting on a payment plan will result in a 30 day ban from sales. A second default will result in a permanent ban from sales.

USD-based sales and terms are defined below:

USD Flatsales

Any sale with a fixed price, regardless of how winners are selected.

Payment for flatsales must be made within 24 hours of receiving the invoice. If payment is not received within 24 hours, Tiny Beans reserves the right to put the design back up for sale.

Any edited posts during flatsales on any platform will be considered invalid.

Tiny Beans reserves the right to make the final decision in any case where the winner of a character is unclear.

USD Customs

Customs are any sales which the customer helps dictate the final design of the character. Prices are not fixed and are based on the complexity and rarity of the design.

Prices for customs must be negotiated prior to the finalization of a sale. Once prices are negotiated, an invoice will be sent. Invoices must be paid within 24 hours of receiving the invoice, or under payment plan rules if the customer has requested a plan.

Once the custom character is completed the customer will be shown the finished character, and may request minor, reasonable changes that were included in the original agreement. If the designer and the customer cannot agree on the final design, DarkHeartedSorrow will pass final judgement. Should the customer not be satisfied, they may be offered a partial refund, on a case by case basis.

Customs will be handled through email, and any undisclosed requests after the finalization of payment will be considered invalid.

USD Auctions

Auctions are any sales which involve bidding to win.

Auctions are exempt from payment plans due to the nature of the sale. Payment for auctions is due within one (1) week of receiving the invoice. Failure to pay for an auction will result in a 30 day ban from all Tiny Beans activities. A second failure will result in a permanent ban.

Any edited posts made during an auction will be considered invalid and will disqualify the offending participant.

Tiny Beans reserves the right to make the final decision in any case where the winner of an auction is unclear.

Banned Persons

Persons listed below are banned until such a time that they are removed from this list. Banned persons may not participate in any Tiny Beans activities on any platform. This ban includes all main and side accounts associated with the banned person.
