WHEREAS, Teacher provides training and consultation in the areas of life and business coaching, energy work, energy healing, meditation, movement, and intuitive development which includes but is not limited to the Program Structure items listed below.

WHEREAS, Client wishes to retain Teacher on the terms and conditions set forth herein to provide such services,

NOW THEREFORE, in consideration of the mutual covenants stated herein, the Parties agree as follows:

1. Disclaimer.

Client understands Cara Viana (herein referred to as "Teacher"), is not an employee, agent, lawyer, doctor, manager, therapist, business manager, registered dietician, licensed physical fitness trainer, financial analyst, psychotherapist or accountant. Client understands his or her participation in this Program will not treat or diagnose any disease, illness, or ailment and if they should experience any such issues they should see their registered physician or other practitioner as determined by their own judgment.

Client understands that Teacher has not promised, shall not be obligated to and will not: (1) procure or attempt to procure employment or business or sales for Client; (2) perform any business management functions including but not limited to, accounting, tax or investment consulting, or advice with regard thereto; or (3) act as a therapist providing psychoanalysis, psychological counseling or behavioral therapy. Client understands that an instructional relationship does not exist between the Parties after the conclusion of the Program. If the Parties continue their instructional relationship, a separate, signed agreement will be entered into.

2. Program Structure

10 weeks of live training and support that includes:

3. Program Length

Program will run for the 10-week period starting October 22, 2026, (herein referred to as "Commitment Period.") Client understands that any/all scheduled calls or other benefits expire at the end of the Commitment Period, and will not be carried-over. All of Client's benefits must be used during the Commitment Period.

4. Refunds

Client is responsible for full payment of fees for the Program, regardless of whether Client completes the Program and regardless of whether Client has selected a lump sum or monthly payment plan. If Client elects to discontinue her participation in the Program for any reason, Client is still responsible for any and all outstanding balance(s). **To further clarify, no refunds will be issued and all scheduled payments must be made on a timely basis.**

5. Group Classes

A reminder email will be sent the day before classes. If the schedule changes, Teacher will notify Client. All calls will try to be stated in Pacific and Eastern Time. If Client misses a group call, recordings will be available and sent within 2-3 business days after the call.

7. Termination

Teacher is committed to providing all clients in the Program with a positive Program experience. By signing below, Client agrees that Teacher may, at her sole discretion, terminate this Agreement, and limit, suspend, or terminate Client's participation in the Program without refund or forgiveness of monthly payments if client becomes disruptive or difficult to work with, inhibits the participation of other Participants (as defined below) or upon violation of the terms. In the event Teacher terminates this Agreement due to a breach by the Participant, the Participant shall immediately cease using the materials. The obligations of the Client under this Agreement shall remain in effect in perpetuity after expiration or termination of this Agreement.

8. Confidentiality

The Teacher respects Client's privacy and insists that client respects the Teacher's and the other participants in the Program (herein referred to as "Participants"). Thus, consider this as a mutual non-disclosure agreement. Any information shared by Participants is confidential, proprietary, and belongs solely and exclusively to the Participant who discloses it. All Parties agree not to disclose, reveal, or make use of any Confidential Information (as defined below) or any transactions during discussions, during group calls, from the forum, workbooks or otherwise.

Client understands his or her name and other identifying information may be displayed amongst Participants and that system errors may occur.

Client agrees not to use such confidential information in any manner other than in discussion with the teacher or other Program Participants during the Program. Confidential information includes, but is not limited to, information disclosed in connection with this Agreement, and shall not include information rightfully obtained from a third party ("Confidential Information").

Both Parties will keep Confidential Information in strictest confidence and shall use the best efforts to safeguard the Confidential Information and to protect it against disclosure, misuse, espionage, loss, and theft.

Further, Client agrees that if they violate or display any likelihood of violating this section the Teacher and/or the other Program Participant(s) will be entitled to injunctive relief to prohibit any such violations to protect against the harm of such violations.

9. Intellectual Property

Material given to Client in the course of Client's work with Teacher is proprietary, copyrighted and developed specifically for the Teacher. Client agrees that such proprietary material is solely for Client's own personal use. Any disclosure to a third party is strictly prohibited unless Client is notified of any exceptions by the Teacher.

Client agrees not to teach any techniques learned in the program unless directly specified of any exceptions by the Teacher.

Teacher's Program is copyrighted and the original materials that have been provided to Client are for Client's individual use only and a single-user license. Client is not authorized to use any of Teacher's intellectual property for Client's business purposes. All intellectual property, including Teacher's copyrighted program and/or course materials, shall remain the sole property of the Teacher. **No license to sell or distribute Teacher's materials is granted or implied.**

Further, by signing below, Client agrees that if Client violates, or displays any likelihood of violating, any of Client's agreements contained in this paragraph, the Teacher will be entitled to injunctive relief to prohibit any such violations and to protect against the harm of such violations.

10. Client Responsibility

Client accepts and agrees that Client is 100% responsible for their progress and results from the Program. Teacher will help and guide Client, however, participation is the one vital element to the Program's success that relies solely on Client. Teacher makes no representations, warranties or guarantees verbally or in writing regarding Client's results from the Program. Client understands that because of the nature of the program and extent, the results experienced by each client may vary.

11. Effect of Headings

The subject headings of the paragraphs and subparagraphs of this Agreement are included for convenience only and shall not affect the construction or interpretation of any of its provisions.

12. Entire Agreement; Modification; Waiver

This Agreement constitutes the entire agreement between the Parties pertaining to the subject matter contained in it and supersedes all prior and contemporaneous agreements, representations, and understandings of the Parties. No supplement, modification or amendment of this Agreement shall be binding unless executed in writing by all the Parties. No waiver of any of the provisions of this Agreement shall be deemed, or shall constitute, a waiver of any other provision, whether or not similar, nor shall any waiver constitute a continuing waiver. No waiver shall be binding unless executed in writing by the Party making the waiver.

13. Force Majeure

In the event that any cause beyond the reasonable control of either Party, including without limitation acts of God, war, curtailment or interruption of transportation facilities, threats or acts of terrorism, State Department travel advisory, labor strike or civil disturbance, make it inadvisable, illegal, or impossible, either because of unreasonable increased costs or risk of injury, for either Party to perform its obligations under this Agreement, the affected Party's performance shall be extended without liability for the period of delay or inability to perform due to such occurrence.

14. Severability

If any term, provision, covenant or condition of this Agreement is held by an arbitrator or court of competent jurisdiction to be invalid, void or unenforceable, the rest of the Agreement shall remain in full force and effect and shall in no way be affected, impaired or invalidated.

15. Counterparts

This Agreement may be executed in one or more counterparts (including by means of facsimile or electronic mail via portable document format), each of which shall be deemed an original but all of which together will constitute one and the same instrument.

16. Limitation of Liability

Client agrees they used Teacher's services at their own risk and that Program is only an education service being provided. Client releases Teacher from any and all damages that may result from any claims arising from any agreements, past or present, between the parties. Client accepts any and all risks, foreseeable or unforeseeable.
