I. CHARACTER & SQUIDWYRM ADOPTIONS

- NO REFUNDS. I cannot accept returns of the character adoptions. All sales are final.
- Clients have to be 18 years or older. I cannot legally do business with minors per Paypal policy. As well, all my artwork portrays content suited for only people 18 years or older.
- Paypal Only.

Owner Rights:

- You may alter the original design.
- You are allowed to resell the character..
- You may change the name, back story, etc. (I will be keeping the original name on my cards, products, etc)
- You will be sent high rez and low rez copies of the original artwork that I've done of the character (if applicable).
- PLEASE ONLY POST THE LOW REZ COPY OF THE IMAGE THAT IS SENT.
- You may not use the original images that are sent for commercial purposes. EX:
 You may not produce and sell prints of the image. You may print out one copy for personal use.

Artist Rights:

I retain the rights to the original images that I created for the character. I am allowed to use those original images as I see fit.

Posting Artwork:

I would prefer to not have the NSFW alt version (if applicable) of your character posted publicly, as I try to keep my NSFW art paywalled. This is just a sure way to make sure that anybody that is viewing my artwork is over 18. Feel free to post it in private places like Discord groups, ETC. I'd just prefer the NSFW version to not be posted on a place like Twitter.

Once payment is received, that character is now yours! Feel free to roleplay, commission or really do whatever you want with them! As outlined above, I ask that you only post the low rez copy of the images online. You may alter the image for personal use as you like. I ask that you source me as the artist.

If you have been one of the lucky ones to receive prize art from me, I simply ask for you to follow these short guidelines:

- I retain the rights to the original images that I created of your character. I am allowed to use those original images as I see fit.
