 - i. The executive made some adjustments to balance income/expenses. We know Insurance will be more. We dropped budget amounts for postage, website, and some events. For Diwali to go ahead it definitely needs an education component because the CL purpose is community safety. We decided not to proceed with the Park Sign but earmarked \$100 for the hall committee and \$7000 for the garden. We noted that we have a bank balance of \$21000 to start the year. The AGM may bring more volunteers and ideas/initiatives. Increased the fundraising target to \$9000 because we know that Garden will have a fundraising component, and Akosua has a plan for canvassing businesses.

- c. Neighbourhood Canvas and Survey
 - DRAFT What We Heard (2024 Allard Community League Survey)
 - Allard and Cavanagh's door-to-door campaign is done but not complete. The survey has 61 responses and will be open until before the AGM
- d. Communication committee. Several community members are interested. ACTION: Tricia will form the committee and chair it until the Engagement Director position is filled, starting with terms of reference.
- e. Events
 - i. Diwali debrief
 - Some people were confused by the timing "8-9 pm," while the show was from 8 to 8:15 p.m. It was a good initiative that met the objective of disseminating information about safe fireworks. Tricia was left to do the cleanup with one other volunteer. Some people were too close. We needed to do a better job of securing the perimeter.
 - ii. Winter Fun Day February 1, 2025
 - 1. Steve organized vendors, tents, food, sleigh rides x3 hours, skating, and firepits. **ACTION:** Permits next, and volunteer call out.
 - iii. AGM March 5, 2025
 - Tricia is negotiating school rentals. The school offers 7:30- 9:30 p.m., and we prefer to use the Library space. ACTION: Tricia will send notice to members by email and on the website by Feb 12. Steve will work on the Annual Report, and Manoj will work on the audit.
- 5. New Business
 - a. Allard Traffic 41st Ave
 - i. Mike reported on recent meetings with Councillor Rice and City of Edmonton staff. 41st ave might get an expansion in a decade. Allard, Chappelle, and Desrochers were represented at the meeting. The last time a traffic assessment was done was in 2022 (during pandemic conditions), so the next step is a new traffic assessment which is planned for 2025. NRC can provide other community contacts. Community member and former board member Diana Powell has been working on bringing attention through local media interviews and meetings with Councillor Rice. Cavanagh traffic is being driven through Allard. Rutherford is avoiding Henday at 111 St. We could explore other mitigating measures, like reducing cars on the road, providing traffic course/driver training/road safety as a membership benefit, or sand/gravel for icy conditions (perhaps HOA role).

ACTION: Mike will prepare something to advocate for higher priority with the City. Mike will contribute information to the January member update.

- b. Rink Shack repairs
 - i. Steve reports that roof repairs cost \$300 and were completed by a professional roofer, but we still need to demo the interior. The window in the door will also be repaired. ACTION: Steve will start permit and community-led project
- c. Outdoor Rink season start.
 - Dec 1st start is the earliest in memory for Allard Rink! Volunteers will be flooding tomorrow
 - ii. Steve applied for and was granted an EPCOR grant for \$800. Purolator will deliver it. As part of the program, we must post about stormwater safety on social media
