Twylla brings 10+ years of experience in the nonprofit sector spanning philanthropy, Medicaid reform, maternal-child health, data analytics, and academia. In her prior work at United Way of Greater Rochester, Dr. Dillion focused on using data and analytics across the fundraising, grantmaking, and evaluation cycle. Additionally, Dr. Dillion has conducted research on breastfeeding, served as program officer for maternal-child health programs, and worked as a research lead on a Patient Centered Outcomes Research Institute (PCORI), the project focused on collaborating with Black moms better to understand contributors to Black maternal mortality/morbidity and develop strategies for better outcomes. During her tenure with the State, she also managed the Teen Parent Services, Healthy Families and Parents Too Soon programs, and played an integral role in the development and implementation of Illinois' Maternal, Infant and Early Childhood Home Visitation program (MIECHV).
