Abstract (Helvetica, 9 point font, italic, bold)

The abstract should provide a brief overview of the entire substance of the article. It should include the background of the study, the legal issue, the objectives of the study, the research method and/or approach, and the conclusion. The abstract must be written in italics, using 9-point Helvetica font, single-spaced, and should not exceed 250 words. It should consist of only one paragraph and be formatted in a single column.

Keywords: The keywords are written in italic letter, no more than 5 words.

1. Introduction (Helvetica 11 point font, bold)

This page explains the background and objective of the study. It is important to give a statement about its scientific novelty through previous literature review of several researchers or studies. In addition, the problems of law or legal issues related to the study are also important element of the article which should be stated clearly. Then, introduction must include the theory that will be used in the discussion.

The articles are written in English, including figures and tables with 11 point-font, Helvetica, 1 line spaced. They should be printed suitable with this template in A4 paper (210 X297 mm), the format of left margin 25 mm, right margin 20 mm, bottom margin 20 mm, and top margin 30 mm. New paragraph begin at 10 mm from left border, while there are no space between paragraphs. All numbers are written in Arabic numerals, except at the beginning of the sentence. Diponegoro Law Review uses Turabian 9th Style based on footnotes in citation and references writing.

*Type of Articles

The articles are full-length original scientific works that consist of the research article and the review article.

- **The Research Article** (min 6.000 words exclude footnotes and references; article more than 20.000 words should consult the journal's editors before submission. 1,5 lines spaced) consist of: a). Introduction, b). Method, c) Literature Review d). Results and Discussion, and e). Conclusion as body text, and Acknowledgement (optional), and References.
- * Integrative approach (mix of doctrinal and non-doctrinal) using research articles type.

- **The Review Article** (min 6.000 words exclude footnotes and references; article more than 20.000 words should consult the journal's editors before submission. 1,5 lines spaced) consist of:
- a). Introduction; b). Discussion; c). Conclusion; Acknowledgement (optional); and References

2. Method (for The Research Article, Helvetica 11 point font, bold)

The research article should include a methods section which consists of approach of method, research specifications, technique of data collection, and analysis methods. While, the opinion or conceptual article writing of the approach of methods should be include in the end part of introduction.

Methods Must display the steps used in the study in detail. Review articles do not need to include methods. A minimum explanation of the method is two paragraphs and contains the technique of conducting the study, not a definition of the method. Methods used in research is related to the study theme and must include the principles, concepts, theories, doctrines, and/or perspectives used.

3. Results and Discussion (Helvetica 11 point font, bold)

In this page describes exploring of scientific findings of the study, followed by scientific discussion which written clearly and concisely. It provides suggestions for future directions of research. The explanation of research article describes scientific finding, analytical and critical writing. Whilst, the opinion or conceptual article should use the term "discussion" in systematical as needed.

Results and Discussion must explain theory and repeat the state of the art to justify novelty. Then the discussion is arranged systematically in sub-headings according to the template. If the article uses a doctrinal approach, then it is not necessary to include a literature review, but if the article is an empirical/socio-legal/integrative approach, it is mandatory to include a literature review before the results and discussion.

Every table and figure which included in the article should be typed the title and numbered with Arabic numerals. The title of a table is placed on the top of table, while the title of the figure is placed at the bottom of the figure. There is single spacing between the number and title with the table. The figures in the article should be printed clearly (font size, resolution and size of the line to be sure printed clearly). Figures and tables or diagrams should be placed in the text, or if their size are too large, they can be placed in the middle of the page. The tables should not contain vertical lines, while the horizontal lines are allowed in terms of importance only.

The of conclusion depends on the problems and should be presented briefly which in accordance with the problems of article. Therefore, if needs an appropriate advice or recommendation to be used as a basis for the next research.
