

St. Peter City Council and Mayor - What do they do?

The **St. Peter City Council** is made up of **6 elected council members** and **1 elected mayor**. These seven individuals work with the appointed **City Administrator** to create and administer public policies affecting the city.

The **mayor** serves a 2-year term, **presides** over the city council meeting and has a vote that is equal to any other council member. Mayors serve as **representatives** of the city at official events and in interactions with other governments (i.e. the state of Minnesota, the federal government, or other cities). According to state law, mayors have several other interesting roles and responsibilities including being the city weed inspector (ensuring that noxious weeds are controlled by landowners) and having the sole ability to declare a local emergency in a city.

Council members are divided into two wards: Ward I (the north side) and Ward II (the south side) and serve four-year, overlapping terms (see map).

The City Council meets twice a month for regular sessions, twice a month for workshops, and once per quarter for goal setting sessions. One of the most important functions of the city council is the hiring or appointment of key city leaders including the City Administrator, Treasurer, Police Chief, Fire Chief, and City Attorney.

The Council can also appoint **independent boards and commissions**. The Council has administrative and legislative authority and responsibility to set policy for the city and ensure that the city is fulfilling its duties under the law. Councilmembers act as **liaisons between the city and the public** and should be concerned with the **future development** of the city. The council oversees the city's **financial affairs** and is responsible for levying city **taxes**, adopting a **budget**, **spending city money**, and **borrowing** money.

The council manages parks, recreational facilities, water, sewage, police and fire services, hospitals, streets, animal regulations, public events, and city employees.

School Board - What does it do?

Independent School District 508 has a **7-member school board**. School board members are elected at large and serve **four-year terms**, with three or four seats open in a given election. To be eligible for election to the school board, individuals must be US citizens, eligible to vote, residents of the school district for at least 30 days before the election, and 21 years of age.

The school board serves as the **governing and policymaking body** for the school district. The school board **manages district facilities and property** and is responsible for **hiring, supervising, and evaluating the superintendent.** School board members serve on **committees** established by the board itself.

Standing committees include (among others) the **instructional program** committee, **co-curricular program** committee, **personnel** committee, **calendar** committee, and **policy review** committee. The policymaking process generally begins with a proposal brought by the superintendent to the school board. Such proposals are open to the public for comment before the committee considers and votes on the proposal. The school board has oversight over things like **curriculum**, **personnel**, **facilities**, and **school policy**.
