End User License Agreement for IsletPassword Mobile Client Software. This End User License Agreement ("Agreement") is entered into between you as the end user and IsletPassword Mobile Client Software.

1. Protection of User Personal Privacy Information

1.1 Scope of Application

When you use the network services of this software, the software automatically receives and records information on your phone, including but not limited to your health data, language used, access date and time, software and hardware feature information, and web page records you need.

1.2 Use of Information

After obtaining your data, the software will not upload it to its own server, but may upload it to iCloud servers.

1.3 Disclosure of Information

- a) The software will not disclose your information to any untrusted third party.
- b) In accordance with the relevant provisions of the law or the requirements of administrative or judicial authorities, disclose to third parties or administrative and judicial authorities.
- c) If you violate relevant laws, regulations or rules, disclosure to third parties is necessary.
