

# PRIVACY POLICY

The 3Bees Global Games respects the privacy of everyone who uses our games. You have the right to know how we collect and use information that you provide through our games.

## Your consent

By using our games you agree to the terms and conditions set forth. You agree to the collection of your personal information and/or non-personal information and if you do not, then you may not use our games.

## Collection of personal information

Personal information specifically identifies the user personally and/or can be used to contact the user online or offline (e.g. full name, physical address, email address, telephone number, photograph, precise geo location information, credit card information and, in some cases, user name). The 3Bees Global Games is committed to complying with the Children Online Privacy Protection Act of 1998 (COPPA). The company does not collect personal identifiable information from children below 13. We do not request that children provide us with personally identifiable information.

## Collection of non-personal information

Non-personal information is information that does not identify the user and cannot be used to contact the user personally (e.g. date of birth, age, ZIP code, non-precise geo location information, gender, unique device ID, IP address). Non-personal information also includes anonymous usage data tied to the user's device (e.g. actions user takes within and outside the game, the date and time of use of the game, game progress, play time, scores and achievements, the URLs that user visited and/or apps the user used before and after using our game). Some information may be collected through the third-party services. They may collect non-personal information from the user.

## Use and disclosure of information

We will not use or disclose personal information about our users otherwise than for the purpose of providing or offering goods and services to them, for any other purpose that you may reasonably expect, for any other purpose authorized by law, or for any other purposes disclosed to or authorized by you. We will, wherever possible, maintain personal information in strict confidence. Any disclosure that is required to be made to any third-party will be made primarily for the purpose of providing or offering goods and services to you.

## Third-party services and advertising networks

The 3Bees Global Games may use third-party services to collect non-personal information from the user but requires such third-party to comply with Children Online Privacy Protection Act of 1998 (COPPA) and other applicable laws. Our privacy policy does not cover the use of analytics and/or tracking tools from third-parties. The use of these third-party services may be subject to separate terms and conditions and privacy policies, and you acknowledge that we are not liable for the use of your personal information by any such third-parties.
