

# APA (7th Ed) Quick Tips

## General Paper Format (more help: General Format)

- Double-spaced, 1 inch margin on all sides
- 12 pt Times New Roman font recommended
- Use only 1 space after a period.
- Running head omitted in student papers (unless instructor says otherwise)

# **Citing Sources**

Cite every source you use in two places: an in-text citation, and a full citation in your References at the end. For variations (e.g., unknown author), consult the "more help" links listed.

#### **In-text citations** (more help: *In-text Basics*)

Formula: Author last name (year of pub) [a verb connecting author to quote/paraphrase] text of quote [in double quotes] or paraphrase (page where info taken from, if applicable). E.g.: Jones (2020) notes that "quoted text should always have an in-text citation" (p. 26).

Include author last name (or editor last name, e.g., for many textbooks) and year of publication within the sentence (this is called a signal phrase) before the quote or paraphrase. Block quote (40+ words): start on new line, double-space & indent block 0.5 inch from left margin. Include page number in parentheses, after quote, if applicable.

#### Examples:

- Calley (2011) supports this view, stating that "92% of respondents preferred the generic version of pharmaceuticals when pricing information was included" (p. 85).
- According to Chen, et al. (2016), "Homeless individuals are far more likely to smoke than adults in the general United States population (p. 641).
- As mentioned in the United States Department of Housing and Urban Development census data (2008), "Average income for social workers in Indiana was below national averages."

## References List (more help: Reference List: Basic Rules)

- Start References list on new page, title is centered, bold: References
- Alphabetize entries by author last name. Double-space all entries.
- Every in-text citation points to an entry in References, and vice versa. Proofread!
