

# The Reorganization of Texas Rangers Act

*Whereas, the Texas Rangers are under the Department of Health and the Secretary of Education, Health, Labor, And Human Services.*

*Whereas, the Texas Rangers should be renamed to represent the whole state, not the individual province.*

*Whereas, the Texas Rangers would serve better under the Department of Justice and Attorney General.*

**Be it enacted by the Assembly of the State of Dixie.**

## **Section 1: Bill Name**

- A. This act shall be referred to as “The Reorganization of Texas Rangers Act.”

## **Section 2: Definitions**

- A. “Dixie Rangers” shall be defined as a Dixie statewide investigative law enforcement agency with statewide jurisdiction in the provinces of Alabama, Arkansas, Florida, Georgia, Louisiana, Mississippi, Oklahoma and Texas, based in the Dixie capital city of Tallahassee.

## **Section 3: Renaming of the Texas Rangers**

- A. The Texas Rangers shall forever be known as the Dixie Rangers.
- B. The Division of Texas Rangers shall forever be known as the Division of Dixie Rangers.

## **Section 4: Reorganization of the Texas Rangers**

- A. The Division of Dixie Rangers shall hereby be removed from the Department of Health.
- B. The Division of Dixie Rangers shall hereby be an official division under the Department of Justice and the Office of the Attorney General.

## **Section 5: Reorganization of the Texas Rangers Jurisdiction Districts**

- A. The Division of Dixie Rangers shall hereby follow the following jurisdiction’s as outlined by the [map](#) provided.
  - a. District 1: District 1 shall be called the Southern Florida District.
    - i. District 1 shall be the jurisdiction of Company A.
      - 1. Company A shall have Headquarters in Miami, Dixie.

- b. District 2: District 2 shall be called the Florgeorgian District.
  - i. District 2 shall be the jurisdiction of Company B.
    - 1. Company B shall have Headquarters in Jacksonville, Dixie.
- c. District 3: District 3 shall be called the Alabamian District.
  - i. District 3 shall be the jurisdiction of Company C.
    - 1. Company C shall have Headquarters in Mobile, Dixie.
- d. District 4: District 4 shall be called the Louisianston District.
  - i. District 4 shall be the jurisdiction of Company D.
    - 1. Company D shall have Headquarters in New Orleans, Dixie.
- e. District 5: District 5 shall be called the Plains District.
  - i. District 5 shall be the jurisdiction of Company E.
    - 1. Company E shall have Headquarters in Little Rock, Dixie.
- f. District 6: District 6 shall be called the Bayou District.
  - i. District 6 shall be the jurisdiction of Company F.
    - 1. Company A shall have Headquarters in Houston, Dixie.
- g. District 7: District 7 shall be called the North Texan District.
  - i. District 7 shall be the jurisdiction of Company G.
    - 1. Company A shall have Headquarters in Dallas, Dixie.
- h. District 8: District 8 shall be called the Border District.
  - i. District 8 shall be the jurisdiction of Company H.
    - 1. Company A shall have Headquarters in Austin, Dixie.

## **Section 6: Role of the Dixie Rangers**

- A. The Dixie Ranger Division is a major division within the Dixie Department of Justice with lead criminal investigative responsibility for the following: major incident crime investigations, unsolved crime/serial crime investigations, public corruption and public integrity investigations, officer involved shooting investigations, and border security operations.

## **Section 7: Ranks of the Dixie Rangers**

- A. The following ranks shall be set to follow suit with the rest of Dixie.
  - a. Recruit
  - b. Ranger I
  - c. Ranger II
  - d. Corporal
  - e. Sergeant
  - f. Staff Sergeant
  - g. Lieutenant

- h. Major
  - i. Colonel
- B. The Attorney General shall make changes to the ranking structure of the Dixie Rangers as they see fit.

### **Section 8: Dixie Rangers Badge and Seal**

- A. The Division of Dixie Rangers seal shall resemble the State of Dixie.
  - a. The Attorney General shall make changes to the Division of Dixie Rangers Seal as they see fit.
- B. The Division of Dixie Rangers badge shall hereby be this [badge](#).
  - a. All Rangers, no matter the rank, within the Division of Dixie Rangers, shall wear this badge when on duty.
  - b. The Attorney General shall make changes to the Division of Dixie Rangers Badge as they see fit.

### **Section 9: Provisional Texas Rangers Clause**

- A. The province of Texas shall be granted the right to continue a provisional division of Texas Rangers under their province jurisdiction.

### **Section 10: Enactment**

- A. This act shall go into effect immediately after it is signed into law.
- B. If any portion of this act is struck down, the rest of the act shall still be in effect.
