Ruben Avertisyan entered the “Twin Towers” Motel in the Slums and Proceeded to pull out a shotgun, upon doing so he fired 2 shots at an Unarmed civilian murdering him. Lieutenant Frank Frazlano was at his estate enjoying that day’s sunny weather from his room, seeing the entire incident play out he ran after Mr. Avetisyan, unfortunately Mr. Avetisyan was long gone from the scene
