ABSTRACT

The abstract is a crucial component of an academic article, as it is often the first section read by potential readers to determine whether the entire paper merits further attention. Therefore, the abstract must be written clearly, concisely, and informatively as a brief representation of the full article. The abstract should contain all essential information necessary for readers to understand the core of the study, including: (1) the objectives of the study, (2) the research approach and methodology, (3) the main findings or results, and (4) the novelty and scholarly contribution of the research. In accordance with the interdisciplinary orientation of the International Journal of Chinese Interdisciplinary Studies (IJCIS), the abstract must explicitly demonstrate the integration of multiple disciplines and highlight how such integration contributes to a deeper and more comprehensive understanding of China, Chinese society, or Chinese culture in global contexts. The abstract should be written as a single coherent paragraph and must not include citations, tables, figures, or unexplained abbreviations. It should reflect the theoretical significance, methodological rigor, and knowledge innovation offered by the study. No information that is not discussed in the



main body of the article should be included. The abstract should be 200–250 words in length.

INTRODUCTION

The introduction should clearly articulate the central problems or issues addressed by the study and demonstrate their relevance within the broader context of interdisciplinary Chinese studies. It must be structured in a way that logically guides the reader from the identified research problem toward the formulation of the research objectives and, where appropriate, the research questions.

The organization of the introduction may vary depending on the disciplinary perspectives involved; however, the overall structure should follow a general-to-specific progression and avoid fragmented or zigzag explanations. The introduction is expected to situate the study within existing scholarship by critically discussing the findings and conclusions of relevant previously published studies. This discussion should clarify how the current research differs from, extends, or integrates prior work, and why it is of scholarly significance.

The introduction must convincingly demonstrate the importance, originality, and interdisciplinary contribution of the research issue under investigation. Authors are required to engage with recent journal literature published within the last five years to ensure the relevance and currency of the theoretical and empirical context. Indirect citations using expressions such as "in" or secondary referencing should be avoided; authors are expected to consult and cite original sources directly.

In the final paragraph of the introduction, the research objectives must be stated explicitly and clearly. The inclusion of the research aim and research questions is optional but strongly encouraged, particularly when they help clarify the interdisciplinary scope and analytical direction of the study.

RESEARCH METHOD

The Research Method section should begin with a general background and overall description of the research design, providing the methodological foundation of the study. This opening functions as a concise introduction to the methodology as a whole and explains the rationale behind the selected research approach, particularly in relation to the interdisciplinary integration central to International Journal of Chinese Interdisciplinary Studies (IJCIS).

Authors are required to clearly describe how concepts, theories, or methods from multiple disciplines are combined or intersected in addressing the research problem. The methodological framework should demonstrate coherence between the research objectives, interdisciplinary perspectives, and analytical strategies employed.

The Research Method section must include, at a minimum, the following components: research participants or sample, research instruments and procedures, and data analysis techniques. The description of the sample or participants should specify relevant characteristics, sampling techniques, and the scope of data sources. The subsection on instruments and procedures must explain the tools, materials, and procedural steps used for data collection in a systematic and replicable manner. The data analysis subsection should describe, in detail, the analytical techniques applied and justify their suitability in addressing the research objectives.

This section should provide sufficient methodological detail to enable replication of the study by other researchers. For qualitative or practice-based research, the structure and emphasis of the methodology may differ; however, the procedures, analytical logic, and interpretive strategies must be described with comparable clarity and rigor.

Overall, the Research Methodology section should convincingly demonstrate that the manuscript is grounded in a methodologically sound, transparent, and rigorous research design, reflecting the scholarly standards and interdisciplinary orientation of IJCIS.

RESULTS AND DISCUSSION

The Results and Discussion section presents and interprets the findings of the study in relation to the research objectives and the interdisciplinary framework adopted. Research results should be reported clearly, systematically, and in sufficient detail to allow readers to understand the empirical or analytical outcomes of the study.

The Results subsection should focus on the presentation of the research findings derived directly from the data or analysis. Results must be reported objectively and coherently, without unnecessary repetition or premature interpretation. Data should be presented in a logical sequence and may be supported by tables or figures where appropriate.

The Discussion subsection aims to interpret and contextualize the results by linking them to the research objectives, theoretical perspectives, and interdisciplinary approaches employed. Authors must support all interpretations and conclusions with evidence from their own research and, where relevant, with reference to generally accepted scholarly knowledge. The discussion should explain how the findings contribute to existing literature, particularly within the field of interdisciplinary Chinese studies, and clarify points of convergence or divergence from previously published research.

Authors are encouraged to address unexpected findings, propose explanations for deviations from earlier studies, and highlight the implications of their results across disciplinary boundaries. The discussion may also suggest directions for future research, including the development of new methodologies, interdisciplinary frameworks, or applications that extend the current study.




Figure 1. Clear Line Drawings Are Essential.

Where appropriate, authors may briefly suggest directions for future research that build upon the findings, especially those that encourage further interdisciplinary exploration.

Overall, the conclusion should demonstrate intellectual coherence, analytical maturity, and interdisciplinary insight, reinforcing the originality and academic value expected by the International Journal of Chinese Interdisciplinary Studies (IJCIS).
