Write at least four paragraphs. In one or two, you can contextualize the topic. In one or two, present background or related studies. In another, state the objective and justification of the study. In another, explain the organization of the text.

The text must be justified and have a line spacing of 1.5, with no space between paragraphs. The first paragraph should not have an indent; the indent is used starting from the second paragraph. All sections of the text must be numbered¹. Every article must be presented using this template.

2. SUBTITLE

Articles should be written between 15 to 30 pages. Number each page. If including figures and tables, please review the editorial policies.

In the writing of the article, follow the rules of English grammar and the correct use of legal English. If a word is highlighted in bold, do not use quotation marks, italics, or underlining. Also, ensure that the direct quotes you include are

You are encouraged to review research databases in SciELO https://scielo.org/es/, Mendeley https://scielo.org/es/, Mendeley https://scielo.org/es/, Mendeley https://www.mendeley.com/ and Alicia https://alicia.concytec.gob.pe/vufind/). Among the references, use academic sources (books, journals, theses, reports), laws, and regulations. Preferably consider sources from databases such as Scopus, SciELO, Web of Science, in English or another language. Additionally, you are invited to review the journal's publications in the Issues tab.

Only include references from the texts cited in the article, in APA format (seventh edition). For more details, you can review the "Guidelines for authors"

Verify that each reference is mentioned in the text. References that have not been cited must be removed.

Funding

If the research did not receive funding, state: "Self-funded". If the research was funded, you can state "The research was conducted with funding from xxxxx" or you may also indicate "This article was prepared within the framework of the research project xxxx from xxxx xxxx".

Conflict of interests

State that the author or authors have no conflicts of interest. State "The author declares no conflict of interest" or "The authors confirm that there are no conflicts of interest".

Authorship contribution

State the contribution of the author in the complete article or, in the case of articles with multiple authors, the contribution of each author. You must specify each author's contribution according to the following: collection or acquisition, analysis or interpretation of data for the work or the conception or design of the work; writing of the work or critical revision of important intellectual content; final approval of the version to be published.

Acknowledgments

You can state: "The author thanks xxxxx for their contributions. It is also appropriate to express gratitude to xxxx xxxx for their observations and revisions in the preparation of this manuscript".

Biography of the author

Include the biography of the author in a maximum of 8 lines. You may highlight their academic degrees, work activities, and previous publications.

Correspondence

Include your institutional email. In the case of articles with multiple authors, provide the email address of the author with whom communication will be made or to whom inquiries will be sent.
