Terms of Service for Achievable

1. Acceptance of Terms

5. User Content

1. You retain ownership of your goals, plans, and task data
2. By using the App, you grant us a license to store and process your content to provide the service

3. You are responsible for the accuracy of information you provide

1. Premium features require a paid subscription processed through RevenueCat
2. Subscriptions auto-renew unless cancelled before the renewal date
