



Ninety Six High School Guidelines for Spectators

Guidelines for Visiting Teams

General Guidelines for All Spectators (venue/sports specifics below):

- Self-Assess using the following screening questions prior to your arrival at any Ninety Six Athletic venues.
 - *Have you had close contact (within 6 feet for at least 15 minutes) with someone who has confirmed or suspected COVID-19 or is in quarantine for possible Covid 19 exposure in the last 24 hours?*
 - *Have you experienced any of the following symptoms during the last 24 hours? Headache ;Fatigue ; Congestion/Runny nose ; Sore throat ; Muscle or body aches/chills ; Nausea or vomiting; Diarrhea; Fever 100.4 or higher; Cough (new or worsening); Shortness of breath/difficulty breathing ; Loss of taste or smell*
 - **If you answer “yes” to any of the above questions, you are asked to stay home.**
- All spectators must wear a face covering at all times, *even while distanced and seated.*
- All spectators must maintain 6 feet social distancing at all times.
- Megaphones and other similar artificial noisemakers are prohibited.
- Visiting bands are not allowed.
- When bleachers are present, spectators are only allowed to sit at their designated seating area.
- For standing room only spots, there will be a designated area, please remain in this area. The six foot social distancing requirement must be maintained in standing room only areas too.
- Stadium chairs and folding chairs are allowed at outside sporting venues.
- No tailgating or social gatherings are permitted on any Greenwood District 52 property.
- No spectators will be allowed on the playing area before, during, or after the contest.
- Parents who are driving athletes home after the event should have a pre-planned meeting spot with your athlete as you will not be able to wait for the athlete in the gym or on the field after the conclusion of the event.

Facility Specific Guidelines

Stadium - Soccer

- Tickets will be sold online at [GoFan](#) for \$6 (SCHSL passes are allowed).
 - Spectator Capacity at this time - Home (475 bleachers standing room); Visitor (275 bleachers and standing room)
 - Grass seating requires standing, sitting on the hill, or bringing your own chairs . Only two spectators will be allowed to occupy each grass circle.
- At this time Middle School will be sold at the gate \$5. Please bring correct change.
- Spectators will enter through the main Ticket Gate.
- Home and visitor spectators may not mingle with each other or visit on opposing sides for any reason.
 - Concessions (pre-packaged snacks and beverages) will be available on the home and on the visitor side.
- All spectators must remain seated or in their designated area.
- No play or social gatherings of any type.
- There will be no tailgating or social gatherings in the parking lots prior to, during, or after the scheduled event.
- Spectators are requested to disperse to their respective vehicles at the conclusion of the games and have their student athletes meet them at their vehicles if they are to ride home with them.

Track-

- Tickets will be sold online at GoFan for \$6 (SCHSL passes are allowed).
- Communities and teams will have an area marked for each team and their spectators involved.
- Grass seating requires standing, sitting on the hill, or bringing your own chairs .
- Spectators must wear masks and social distance at all times.
- There will be no tailgating or social gatherings in the parking lots prior to, during, or after the scheduled event.
- Spectators are requested to disperse to their respective vehicles at the conclusion of the games and have their student athletes meet them at their vehicles if they are to ride home with them.

Baseball/Softball

- Tickets will be sold online at GoFan for \$6 (SCHSL passes are allowed)
- Home and visitor spectators may not mingle with each other or visit on opposing sides for any reason.
- Grass seating requires standing, sitting on the hill, or bringing your own chairs .
- Spectators must wear masks and social distance at all times.
- There will be no tailgating or social gatherings in the parking lots prior to, during, or after the scheduled event.
- Spectators are requested to disperse to their respective vehicles at the conclusion of the games and have their student athletes meet them at their vehicles if they are to ride home with them.
